APPLICANT'S STATEMENT OF CASE

In each of these two cases, Matador Production Company seeks an order (1) creating a non-standard, 160-acre spacing and proration unit; and (2) pooling all uncommitted interests in the Bone Spring formation for each non-standard spacing and proration unit.

In Case No. 15611, the non-standard spacing and proration unit will be comprised of the S/2 S/2 of Section 20, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico. This non-standard spacing and proration unit will be the

project area for the proposed **Stebbins 20 Federal No. 124H Well**, which will be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) to a standard bottom hole location in the SE/4 SE/4 (Unit P) of Section 20.

In Case No. 15612, the non-standard spacing and proration unit will be comprised of the N/2 S/2 of Section 20, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico. This non-standard spacing and proration unit will be the project area for the proposed **Stebbins 20 Federal No. 123H Well**, which will be horizontally drilled from a surface location in the NW/4 SW/4 (Unit L) to a standard bottom hole location in the NE/4 SE/4 (Unit I) of Section 20.

The project areas for both wells are located in the Avalon; Bone Spring, East Pool (70870). The completed interval for this well will remain within the 330-foot standard offset required by the Statewide Rules set forth in 19.15.15 NMAC.
