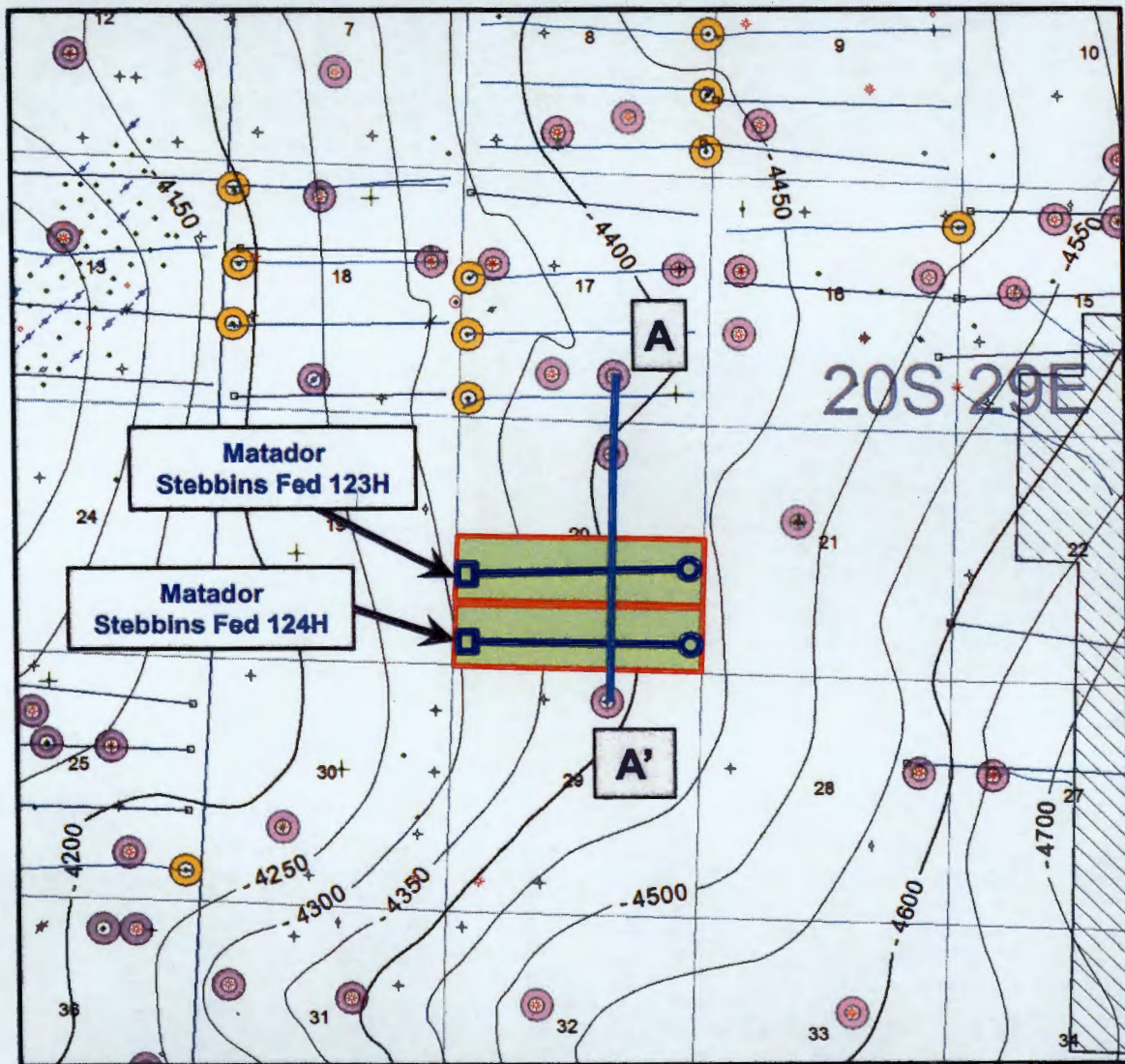
Locator Map

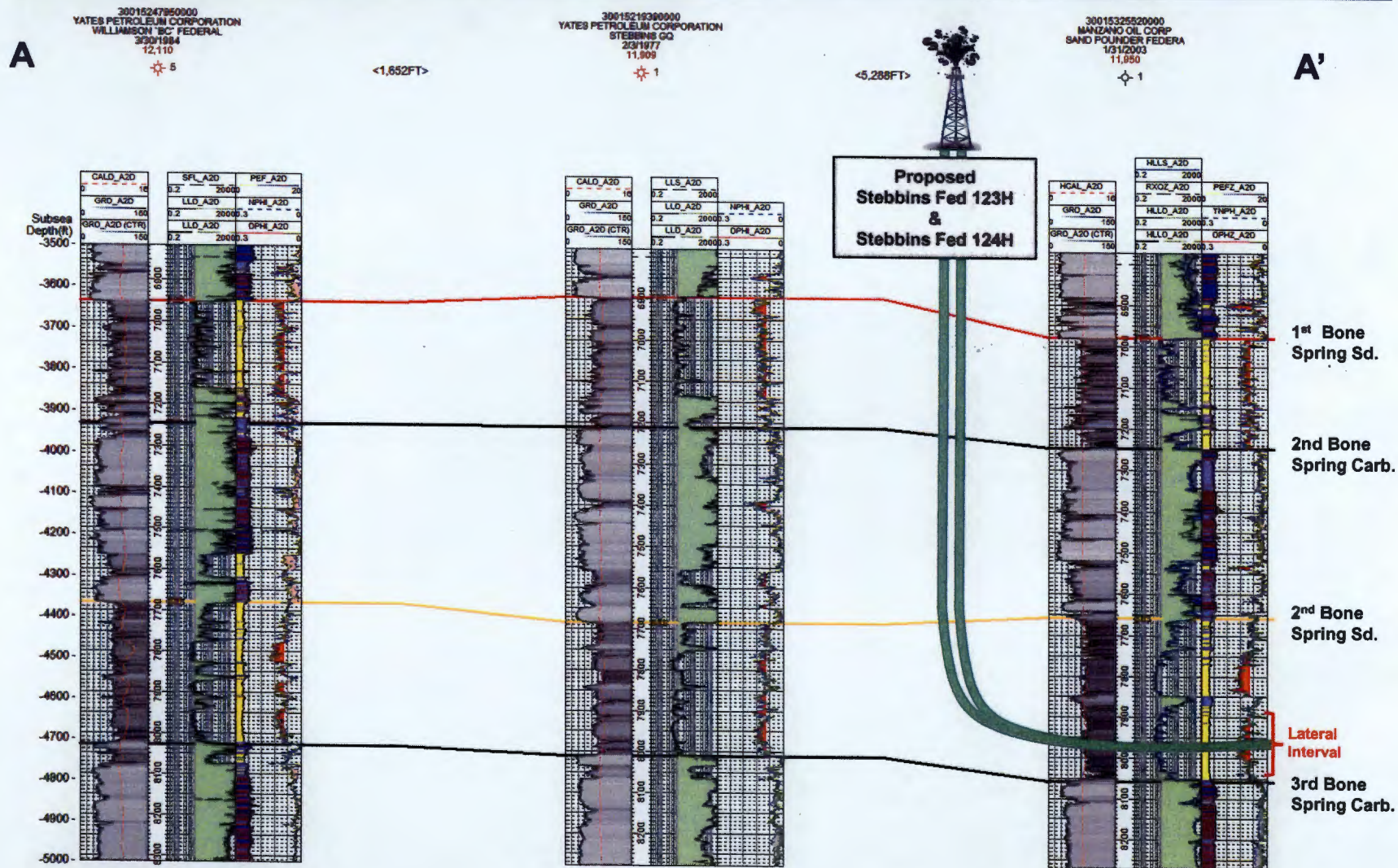

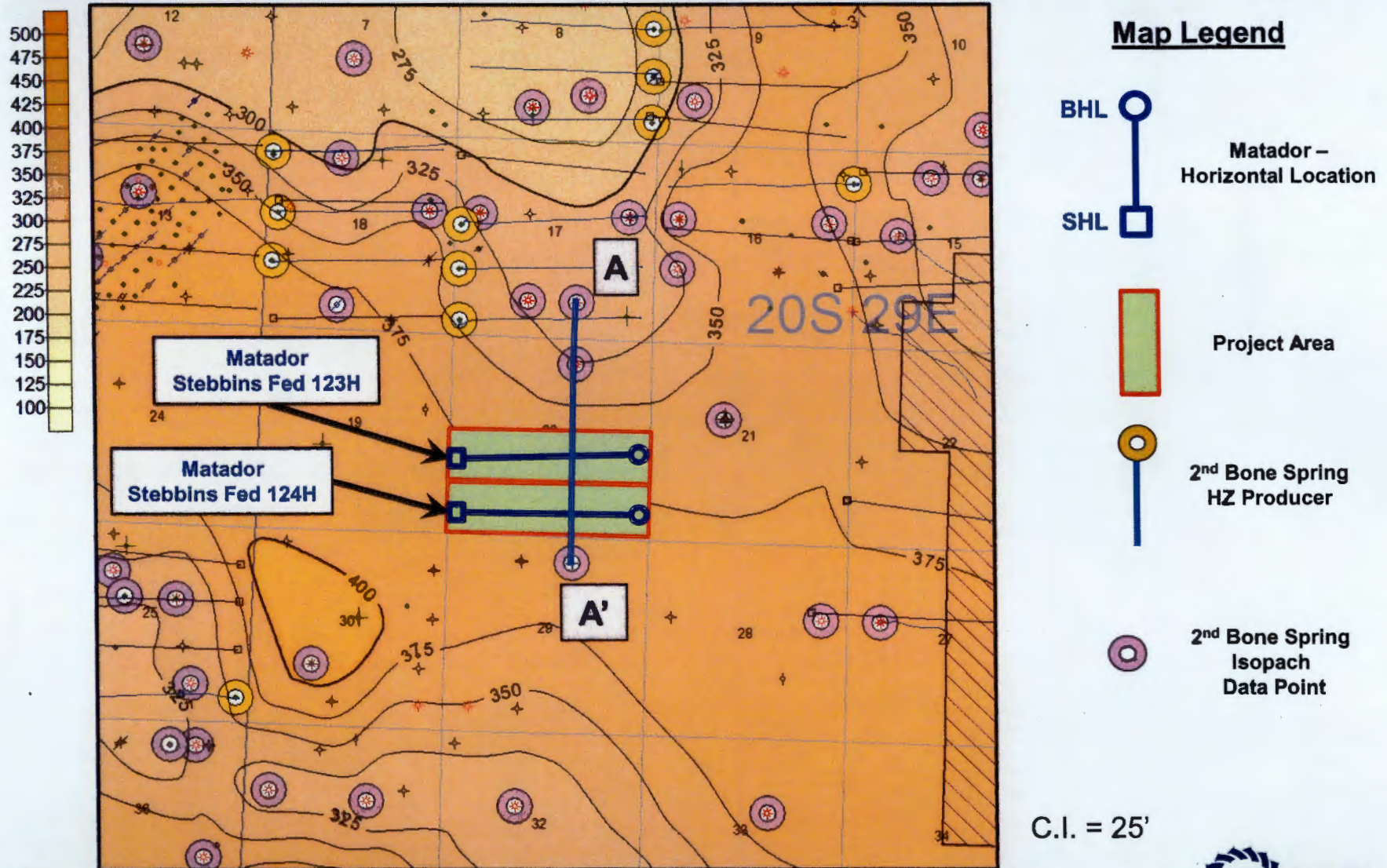
WC-015 G-04 S202920D; Bone Spring Pool (Pool Code: 98015) Stratigraphic Cross Section A - A'

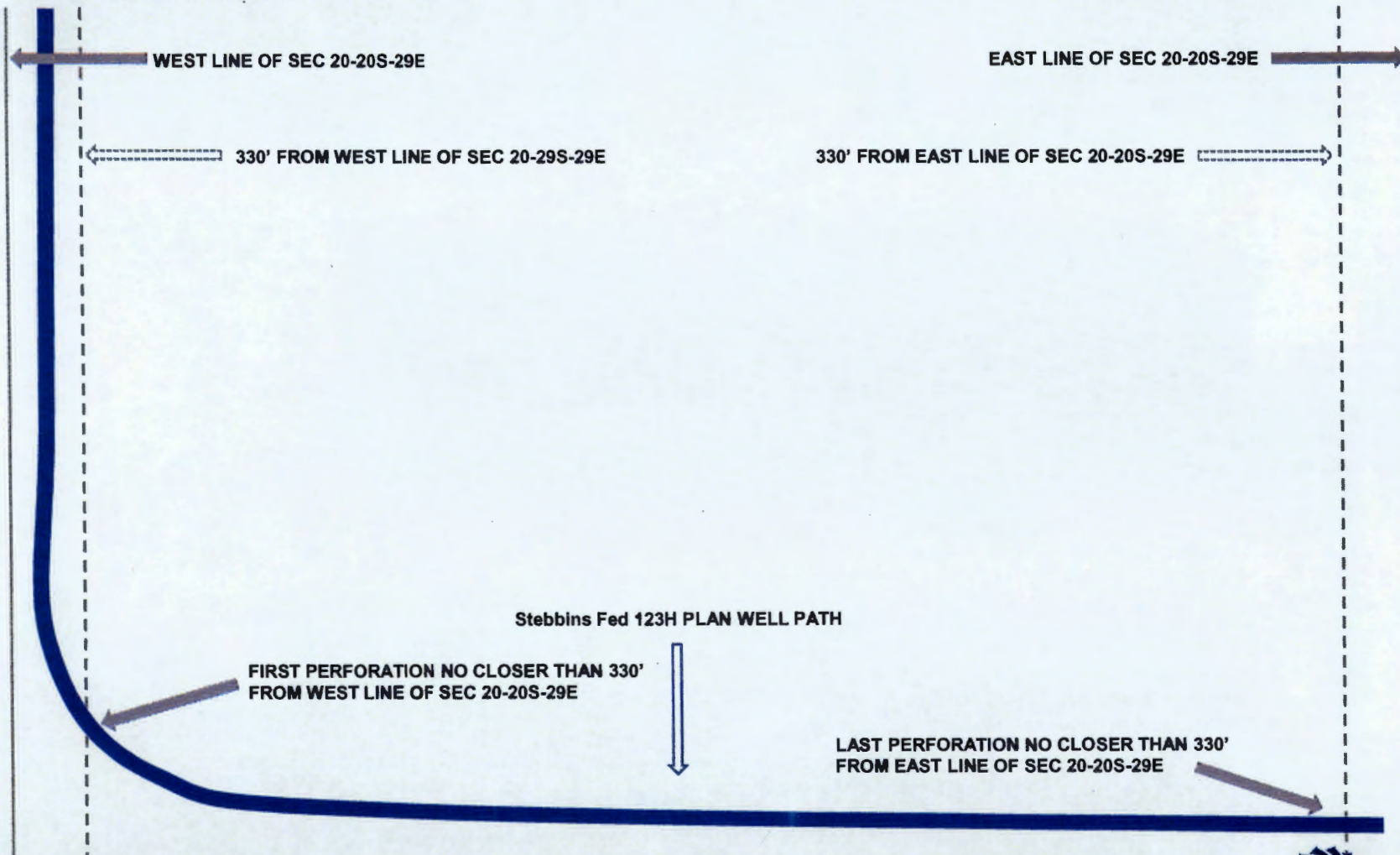

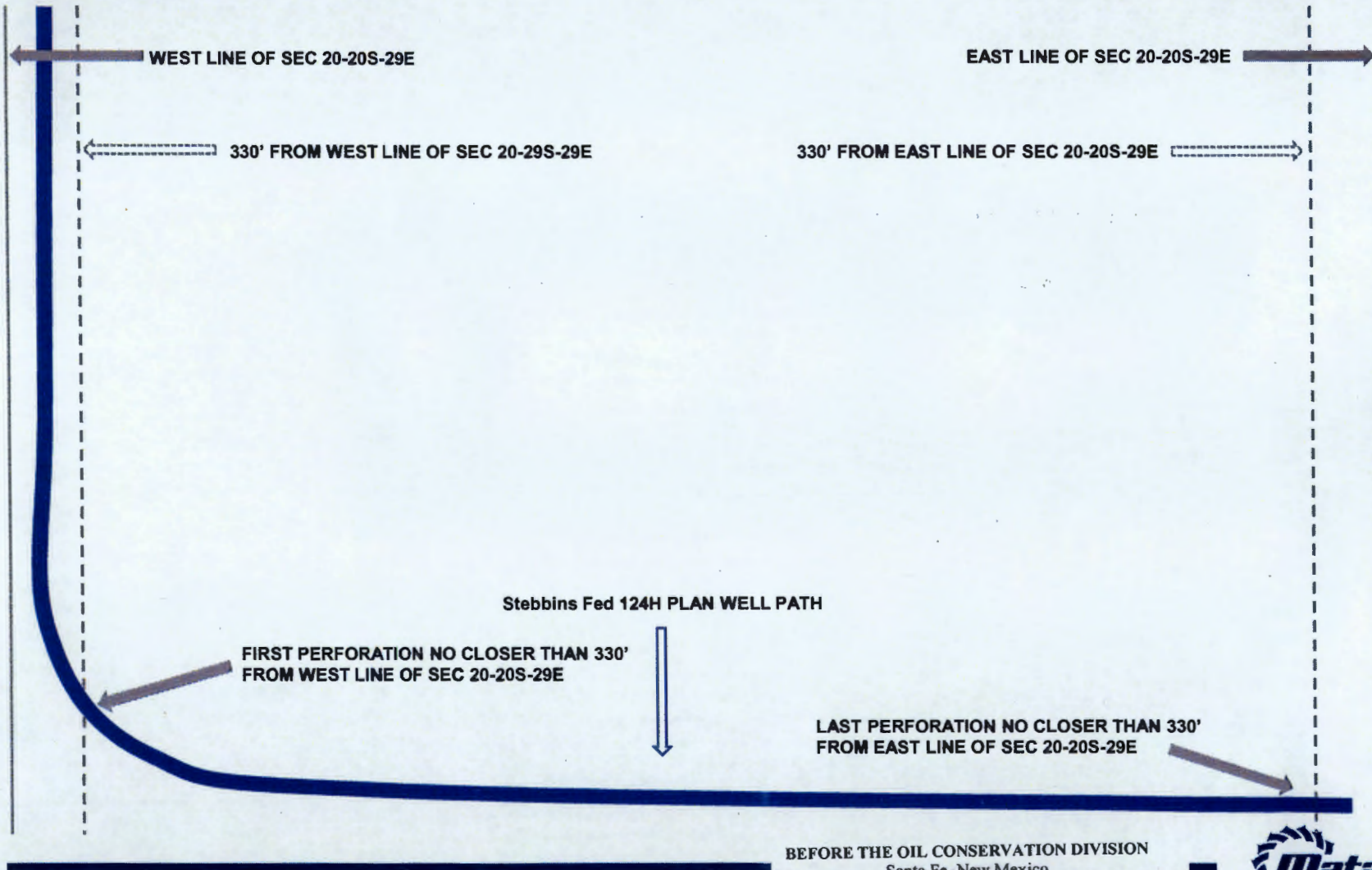
