2 EXAMINER JONES: I think we're on page 7,  
3 which is BC Operating. Let's call Case Number 15538,  
4 re-opened, application of BC Operating, Incorporated to  
5 re-open Case Number 15538 to pool the interests of  
6 additional leasehold owners under the terms of  
7 compulsory pooling Order Number R-14227, Eddy County,  
8 New Mexico.

9 Call for appearances.

10 MS. KESSLER: Mr. Examiner, Jordan Kessler,  
11 from the office of Holland & Hart, on behalf of the  
12 Applicant.

13 EXAMINER JONES: Any other appearances?

14 MS. KESSLER: Mr. Examiner, no witnesses.  
15 Today this case will be presented by affidavit.

16 EXAMINER JONES: Okay.

17 MS. KESSLER: This case was -- is  
18 re-opening for Order R-14227, entered on October 31st of  
19 2016. That order created a 320-acre spacing unit in the  
20 Wolfcamp Formation, the Wolfcamp; Salt Draw Gas Pool,  
21 which consisted of the east half of Section 34 in  
22 Township 24 South, 28 East of Eddy County, and it pooled  
23 uncommitted interest owners in that pool.

24 BC subsequently, after the order was  
25 entered, identified additional working interest owners

1 that had not been subject to the terms of the compulsory  
2 pooling order, so we are re-opening the case to pool  
3 that additional interest owner.

4 We have continued with the numbering of the  
5 exhibits from the original case, so this is Exhibit 2.

6 EXAMINER JONES: Okay.

7 MS. KESSLER: That is an affidavit from  
8 Caleb Hopson who testified by affidavit in the original  
9 cases. It details his attempt to reach an agreement  
10 with the working owner who is RKC, Incorporated. They  
11 have been -- BC has been in communication with that  
12 interest owner but has not been able to reach an  
13 agreement and has been told by that interest owner to  
14 proceed with pooling, and they do not object.

15 Attachment A to Exhibit 2 is the original  
16 pooling order.

17 Attachment B lists the interests. Both  
18 you'll see, in yellow, are the parties that were pooled  
19 pursuant to the original order, and then the interest of  
20 RKC in blue who we're seeking to pool in this hearing.

21 C is a well-proposal letter that was sent  
22 to RKC, and that was sent on September 21st.

23 Attachment D is the AFE that was included  
24 with a well-proposal letter.

25 And finally, Attachment E is a notice

1 affidavit from Holland & Hart with an attached letter  
2 providing notice to RKC, and that green card has been  
3 returned.

4 So nothing else in terms of the original  
5 order. BC is asking that this additional interest owner  
6 be pooled pursuant to the terms of the original order.

7 EXAMINER JONES: As of the date of the  
8 original pooling order?

9 MS. KESSLER: Correct. And this well has  
10 not yet been drilled.

11 EXAMINER JONES: Oh, okay. Okay.

12 EXAMINER WADE: I'm not sure the order will  
13 reflect that these people are pooled as of the date of  
14 the original order. It will just be as of this  
15 application and issuance of a new order.

16 MS. KESSLER: I think that's correct. And  
17 since the well hasn't been drilled, we're not asking for  
18 any sort of allocation.

19 EXAMINER JONES: Okay. This was Exhibit  
20 Number 2? We'll just -- Exhibit Number 2 and all of its  
21 attachments will be admitted, and we'll take Case Number  
22 15538, re-opened, under advisement.
