Dear Sirs:

As per the attached letter dated June 6, 2016, the Bureau of Land Management concurs with ConocoPhillips Company, as Operator of the San Juan 32-8 Unit, that the San Juan 32-8 20 Mesaverde well proved capable of producing in paying quantities as of 1996, when it was sidetracked to the Mesaverde formation. As such, 40 acres associated with the NW/4SW/4 drillsite of the well will be brought into the San Juan 32-8 Unit Mesaverde Participating Area (PA) with the 20th Expansion, effective December 1, 1996.

Well History:

The San Juan 32-8 20 well was initially completed to the Mesaverde formation on 06/28/1957 and was deemed *not* capable of producing in paying quantities at that time. The 320.57 acre well spacing continued to report to the lease. Effective January 1, 1980, with the 17th Expansion of the Mesaverde Participating Area (PA), 280.57 acres of the referenced well spacing was brought into the PA as an Intervening Drill Block. The 40 acre NW/4SW/4 drillsite of the non-commercial San Juan 32-8 20 well

was held out of the PA as per the terms of the San Juan 32-8 Unit Agreement dated October 21, 1962. On November 5, 1996, the San Juan 32-8 20 well was sidetracked to the Mesaverde formation and should have been resubmitted for determination at that time, pursuant to Section 11. (a) Participation after discovery. MESAVERDE AND SHALLOWER FORMATIONS, of the San Juan 32-8 Unit Agreement:

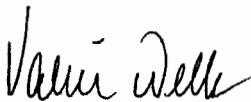
"If any Drilling Block, or portion thereof, on which a well has been drilled is not included in a participating area, conformably with the provisions of this agreement, and thereafter should become capable of production in paying quantities by reason or repressuring or other methods of secondary recovery, such drilling block or portion thereof shall be admitted to the applicable participating area on recommendation of the Unit Operator and approval thereof as provided for the inclusion of lands in a participating area..."

ConocoPhillips Company became aware of the oversight in March of this year and the well was resubmitted to the Bureau of Land Management for determination.

Operator respectfully requests Bureau of Land Management review and approval of the enclosed schedules for the 20th through 24th Expansions of the San Juan 32-8 Unit Mesaverde Participating Area.
