Randy:

I would like to meet with you in person to go over all of this but since we haven't been able to get together yet I thought I would send you this summary to tee it up.

The first thing I'd like to talk to you about is we (through Marbob) farmed in two half-sections (16-26S-27E, and 30-26S-28E) from you with BIAPO elections on a well by well basis. So far, seven wells in these two sections have reached payout with more on the way;

Cluster State Com 1H, 2H, 3H, 4H, 5H

Way South State Com 4H

F.U.N. State Com 1H

I received the payout elections back from Ken Dixon and we have changed our decks to reflect your new working interest(s). However, we have not executed the back-in assignments yet. We are hoping that you will agree to amend both farmout agreements to use our already existing JOAs instead of the ones attached to the agreements, since we would strongly prefer to operate under a single JOA.

I've attached full copies of both farmouts with their AAPL 1982 JOAs in addition to our currently existing JOAs. I don't think there should be any problem with Section 16 (Cluster State wells) since both are 1982 forms. However, our existing section 30 (Way South and F.U.N.) JOA is on the 1977 AAPL form. I've also attached a copy of the back-in assignment we propose to use since the farmout agreements don't have one.

The second thing is we have some outstanding issues with the wells in the former SRO State Unit. It is a bit complicated and I hope you don't mind me attaching an email I sent to Kathie Craft explaining part of the issue. It is also worth mentioning that we are still waiting on the after unit dissolution DOTOs for the SRO wells.

I've got a meeting this Wednesday morning but so far I'm wide open the rest of the week. If you can shake free for 30-45 minutes let me know and I'll come over.
