COG Operating LLC ("COG"), as Operator, proposes to drill the SRO State Com #43H well as a horizontal well at the above-captioned location to a TVD of approximately 8,000' and a MD of 17,800' to test the 2nd Bone Spring Sand Formation ("Operation"). The total cost of the Operation is estimated to be \$10,451,500, and a detailed description of the cost is set out in the enclosed Authority for Expenditure ("AFE"). COG anticipates that it will spud the well on or before July 22, 2014.

COG is proposing to drill this well under the existing SRO State Exploratory Unit Operating Agreement dated May 8, 2009.
