13 MS. KESSLER: Mr. Examiner, my name is
14 Jordan Kessler, from the Santa Fe office of Holland &
15 Hart, on behalf of the Applicant.

16 This case was heard a month ago. At that
17 time we presented three witnesses: The landman, a
18 geologist and an engineer. As you may recall, there was
19 an issue with unmarketable title. There was an heir
20 that had been identified that had not been noticed at
21 the time.

22 We have included Exhibit 16, which is the
23 next sequential exhibit, an affidavit from my office and
24 attached a letter providing notice to that heir, William
25 Hollis, who is potentially identified as owning an

1 interest. He has been notified. There is a green card
2 returned.

3 And I'd ask this case be taken under
4 advisement.

5 EXAMINER DAWSON: Okay.

6 EXAMINER BROOKS: Is this the only heir
7 that you know about that had not been noticed
8 previously?

9 MS. KESSLER: That's correct. All of the
10 other heirs that we had identified as potentially having
11 an interest have been identified.

12 EXAMINER BROOKS: Okay. Thank you.

13 EXAMINER DAWSON: Do you have any
14 questions, Mr. Goetze?

15 EXAMINER GOETZE: No questions.

16 EXAMINER DAWSON: I have no questions
17 myself.

18 So Case Number 15680 will be taken under
19 advisement.

20 Thank you, Ms. Kessler.
