- 2 CHAIRMAN CATANACH: The next order of
- 3 business today is the final disposition in Case Number
- 4 15487, which is the joint application for rehearing of
- 5 Order Number 14164-D, application of the New Mexico Oil
- 6 Conservation Division through the supervisor of District
- 7 II for an emergency order suspending certain approved
- 8 applications for permits to drill, and for adoption of
- 9 special rules for drilling certain areas for the
- 10 protection of fresh water, Chaves and Eddy Counties,
- 11 New Mexico.
- 12 This case was reheard by the Commission on
- 13 May 18th, 2017, and open deliberations were held on June
- 14 13th at the previous hearing. At that time, as I
- 15 recall, the Commission reached a decision on the matters
- 16 heard at rehearing.
- 17 Commissioners, the draft order in that case
- 18 prepared by the Commission attorneys has been provided
- 19 to you prior to the hearing. I will make -- I will
- 20 point out that there was some corrections made on that
- 21 draft order this morning to the actual -- to the actual
- 22 rule, not to the order part but to the actual rule.
- 23 Apparently we had -- Part D of that rule, we had left
- 24 out some additional paragraphs, two and three, that we
- 25 had adopted at the meeting. So those changes were made

1 this morning, and we do -- we did incorporate -- to the

- 2 best of my knowledge, the order states what the intent
- 3 of the Commission was at the last hearing. I did review
- 4 it again this morning, and so if you want to take time
- 5 yourselves and review the rule, we can do that, or if
- 6 you prefer not to, that would be fine also.
- 7 COMMISSIONER BALCH: (Not within the
- 8 hearing of the court reporter.)
- 9 CHAIRMAN CATANACH: No, sir. This is a
- 10 very long -- well, the order, yeah. The changes that
- 11 were made, it's just two pages.
- 12 Is it your desire to review?
- 13 COMMISSIONER BALCH: I'll just take a look.
- 14 (Pause in proceedings, 9:05 a.m. to 9:07
- 15 a.m.)
- 16 CHAIRMAN CATANACH: Okay. I guess, at this
- 17 time, I would put forth a motion to approve Order Number
- 18 RS-14164-F. Do I hear a motion to approve the order and
- 19 the rule change in that case?
- 20 COMMISSIONER BALCH: I so move.
- 21 COMMISSIONER MARTIN: Second.
- 22 CHAIRMAN CATANACH: All in favor?
- 23 (Ayes are unanimous.)
- 24 CHAIRMAN CATANACH: Okay. So we're done
- 25 with that.

Page 4 Anything further on that? MR. BRANCARD: No. We have to simply wait, again, 20 days for the refile period, and we file the rule. CHAIRMAN CATANACH: So we don't know the effective date of the rule yet --MR. BRANCARD: No. CHAIRMAN CATANACH: -- until we file with the Registry? MR. BRANCARD: No. CHAIRMAN CATANACH: Okay. (Case Number 15487 concludes, 9:08 a.m.)
