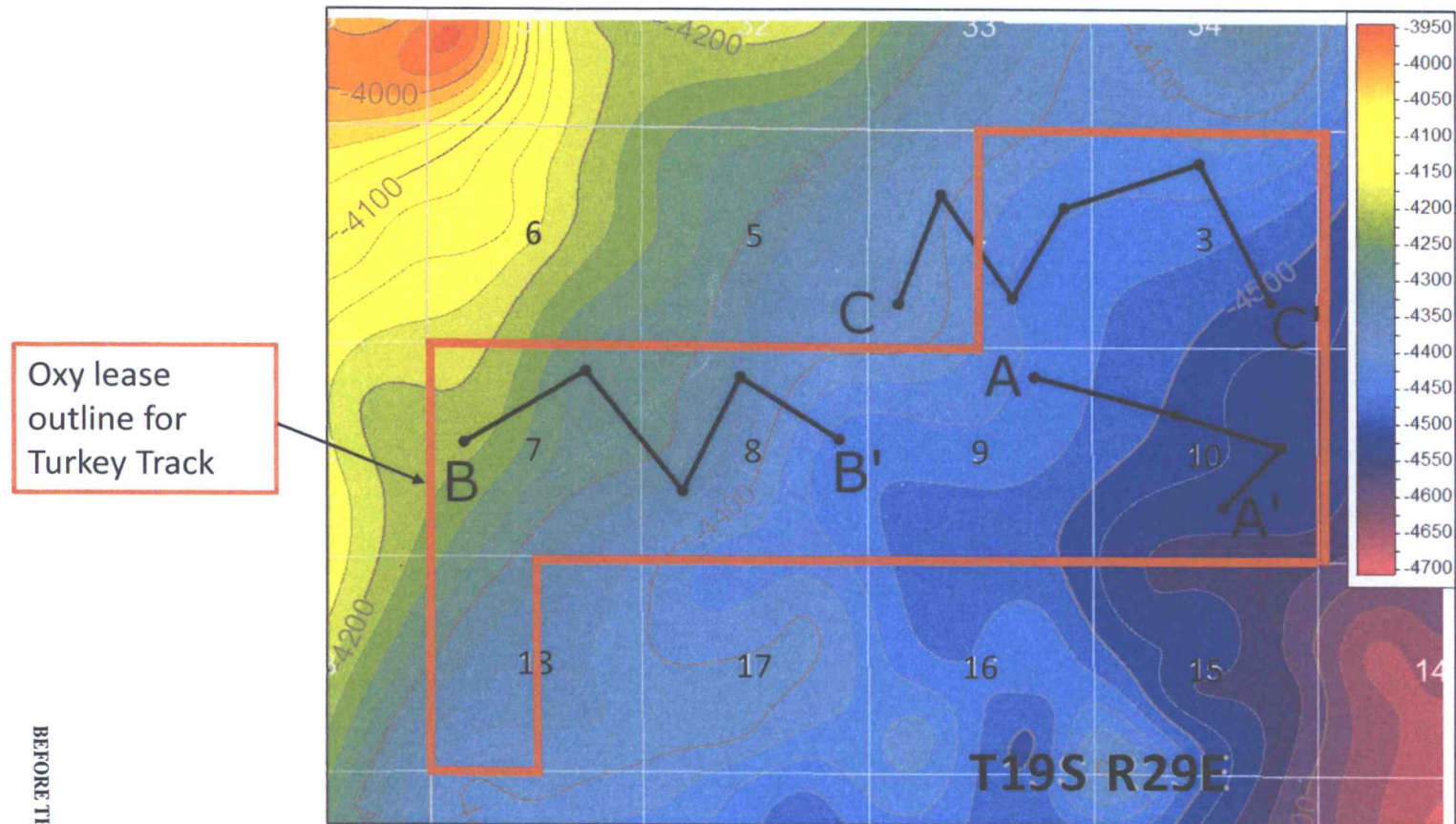

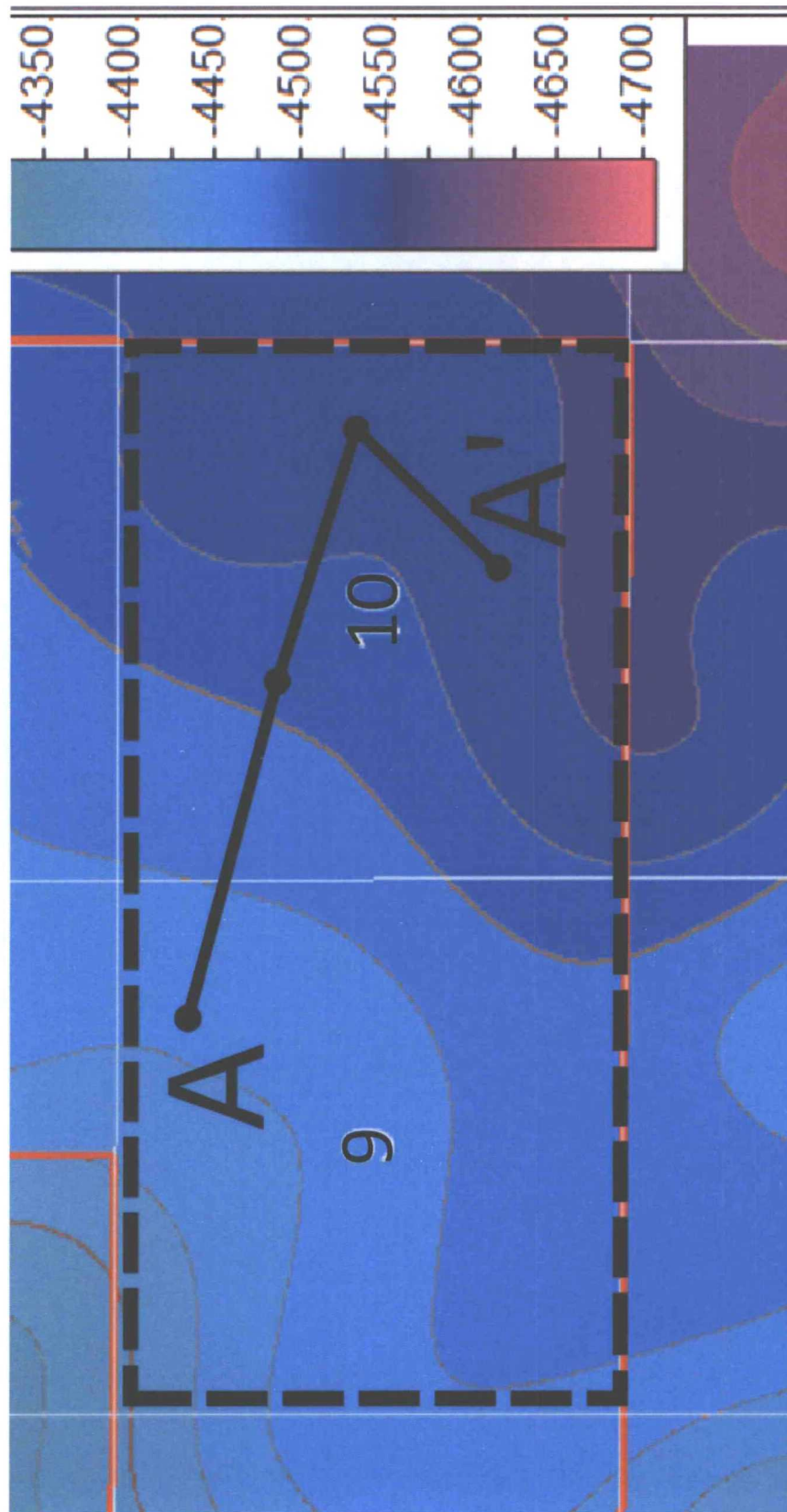

Turkey Track Leases



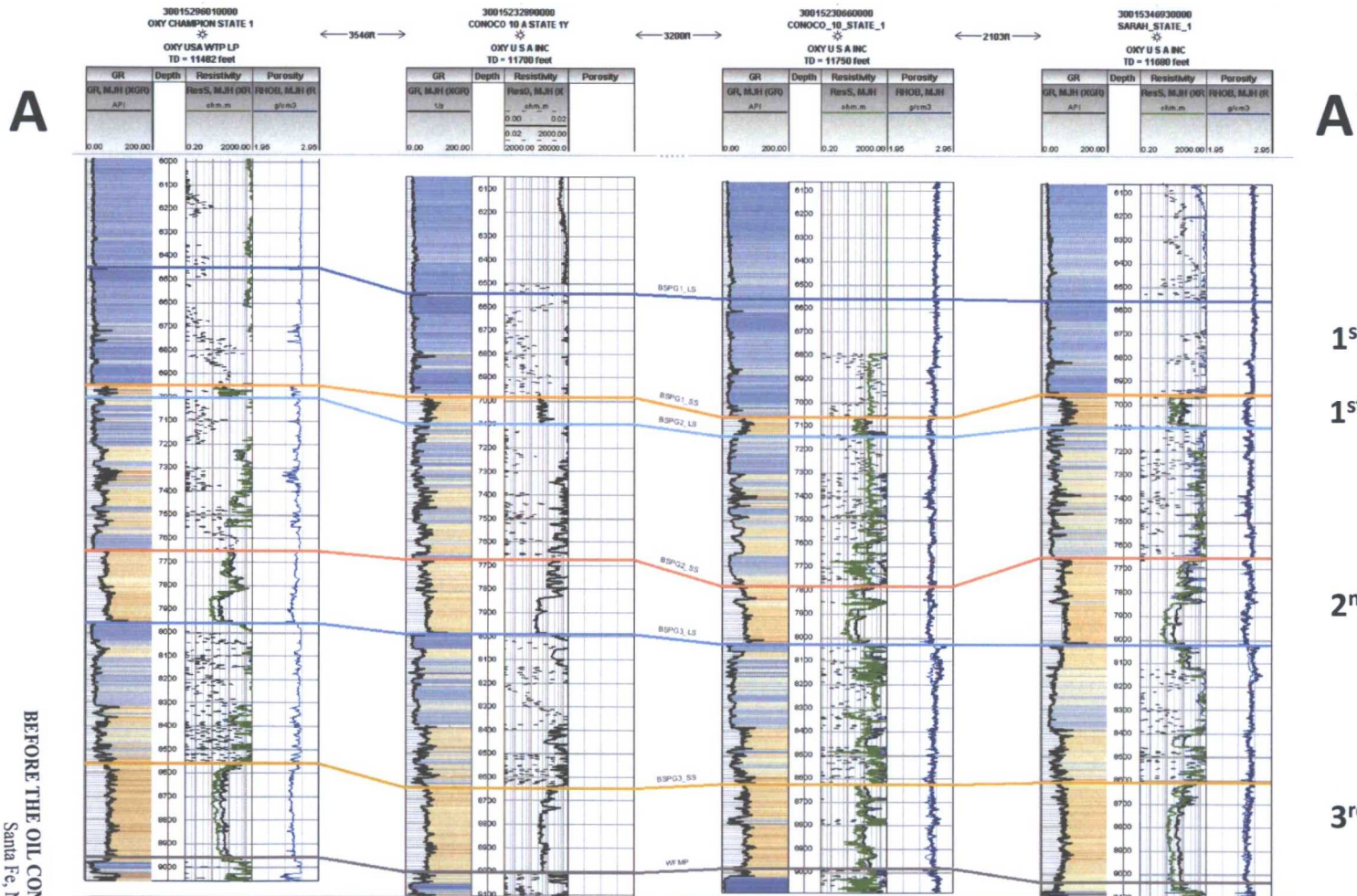
Structure Map
