2 EXAMINER GOETZE: Good morning, ladies and
3 gentlemen. This is the Examiner Hearing for the Oil
4 Conservation Division, Docket Number 29-17, on Thursday,
5 August the 3rd, 2017 in Porter Hall. Today I'm your
6 examiner. My name is Phillip Goetze. And to my right,
7 your left, is counsel for the Examiner, Mr. David
8 Brooks.

9 The first item of the hearing will be to go
10 through the docket and notice the continuations and
11 dismissals.

12 Page 1 of the docket, Case Number 15767 has
13 been continued to August 31st.

14 Page 2, Case Number 15763 has been
15 continued to August 17th.

16 Page 3, Case Number 15773 and 15774 have
17 been continued to August 17th. Case 15775 has been
18 continued to August 31st. Case 15776 has been continued
19 to August 31st. Case 15777 has been continued to August
20 31st.

21 Page 4, Cases 15778, 15779, 15780 and 15781
22 have all been continued to August 31st.

23 Page 6, Cases Number 15782 and 15783 have
24 been continued to August 31st. Cases 15785, 15786 and
25 15787 have been continued to August 31st.

1 Page 7, Case Number 15755 has been
2 continued to August 31st, and Case Number 15788 has been
3 continued to August 17th.

4 Page 8, Case Number 15789 has been
5 dismissed. Case 15790 has been dismissed, and Case
6 15751 has been continued to August 31st.

7 These are the summaries of the changes to
8 the docket which have been provided prior to hearing.

9 Are there any additional changes requested?

10 MS. KESSLER: Mr. Examiner, on page 6, Case
11 Number 15784, I believe that COG had filed a motion to
12 continue to August 31st on that case.

13 MR. HERRMANN: Mr. Examiner, Case 15751, I
14 just wanted to clarify that that was continued to August
15 17th.

16 EXAMINER GOETZE: What page we on?

2 Case Number 15756, we'd like to request that that case
3 be heard first this morning.

4 EXAMINER GOETZE: Okay. Very well. If
5 there are no other additions, changes or addendums,
6 we'll proceed into the docket.
