2 EXAMINER GOETZE: Call Case Number 15673,
3 application of Mewbourne Oil Company to re-open Case
4 Number 15673 for a nonstandard spacing and proration
5 unit and compulsory pooling, Eddy County, New Mexico.

6 Call for appearances.

7 MR. BRUCE: Mr. Examiner, Jim Bruce of
8 Santa Fe representing the Applicant. I have no
9 witnesses.

10 Mr. Examiner, this matter was heard this
11 summer and testimony was presented on all the usual
12 nonstandard unit and pooling matters. After it was
13 heard, Mr. Brooks requested that I re-open the matter
14 because the way he read the rules I had to -- the well
15 unit is comprised of the east half of Section 12 in the
16 southeast quarter of Section 1. And Mr. Brooks advised
17 me I needed to notify all of the interest owners, not
18 just the operator in the northeast quarter of Section 1.
19 So that's what I did.

20 So I submitted as Exhibit A an affidavit
21 from Corey Mitchell, landman at Mewbourne, identifying
22 the royalty working and overriding royalty interest
23 owners in the northeast quarter of Section 1.

24 And Exhibit B is my Affidavit of Notice to
25 all of those parties notifying them of re-opening the

1 case, and I got green cards back from everybody. So --

2 EXAMINER GOETZE: Does that make you very
3 excited, all that anxiety (laughter)?

4 MR. BRUCE: I can hardly stand the joy of
5 getting green cards back anymore.

6 And so nobody objected.

7 One thing is that all the parties being
8 notified already own an interest in the well unit, so
9 I'm presuming they just want to get the well drilled.
10 And that's referenced in Mr. Mitchell's affidavit.

11 So with that, I would ask that Exhibits A
12 and B be admitted into the record and the case be taken
13 under advisement.

14 EXAMINER GOETZE: Since you requested
15 this --

16 EXAMINER BROOKS: I did request it. I
17 guess I shouldn't -- no need to put this on the record.
18 Let's go off the record for a minute.

19 (Discussion off the record, 9:49 a.m. to
20 9:50 a.m.)

21 EXAMINER GOETZE: Back on the record again.
22 Exhibits A and B are so entered into the
23 case.

24 (Mewbourne Oil Company Exhibit Letters A
25 and B are offered and admitted into

1 evidence.)

2 EXAMINER GOETZE: And the case is taken
3 under advisement.

4 Thank you.
