- 2 EXAMINER DAWSON: So what we'll do now is
- 3 we'll go to Case Number 15689, which is number 24 on the
- 4 list.
- 5 Can I call for appearances, please?
- 6 And Case Number -- let me see. Case number
- 7 24 is 15689, re-opened. This is continued from the
- 8 October 12th, 2017 Examiner Hearing. It's the
- 9 application of Mewbourne Oil Company to re-open Case
- 10 Number 15689 for a nonstandard spacing and proration
- 11 unit and compulsory pooling, Eddy County, New Mexico.
- 12 And I understand, Mr. Bruce, that that
- 13 case -- the only thing lacking on that case was the
- 14 notice?
- 15 MR. BRUCE: Yes, Mr. Examiner. In that
- 16 case -- it has been presented. And in that case,
- 17 Mewbourne seeks to form a nonstandard unit, the
- 18 southeast quarter of Section 23 and the south half of
- 19 Section 24 in 24 South, 28 East.
- 20 After the hearing was originally taken
- 21 under advisement, Mr. Brooks informed me that I --
- 22 rather than offset operators, I had to notify all of the
- 23 interest owners in the northeast quarter of Section 23
- 24 and the southwest quarter of Section 23. However -- and
- 25 I don't have copies of the C-102s. However, after

1 further research, there is an existing well in the north

- 2 half of Section 23 operated by Marathon. It has been
- 3 drilled and, I believe, completed. So, therefore, I did
- 4 not give notice to the northeast quarter Section 23
- 5 interest owners.
- 6 And, likewise, in the southwest quarter of
- 7 Section 23 and the west half of Section 26, Mewbourne
- 8 has filed an APD and will be drilling a separate well,
- 9 so those interest owners are also taken care of.
- 10 So -- and I would just ask you to take
- 11 administrative notice of the Division's well records.
- 12 And with that, I would just ask that the case be taken
- 13 under advisement.
- 14 EXAMINER DAWSON: Okay.
- 15 EXAMINER BROOKS: I have no -- with that,
- 16 we will proceed as you recommend.
- 17 EXAMINER DAWSON: So number 24, which is
- 18 Case Number 15689, re-opened, will at this time be taken
- 19 under advisement.
