STATEMENT OF THE CASE

APPLICANT

Mewbourne Oil Company seeks an order approving a 312.51-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of Lot 1, NE/4NW/4, and N/2NE/4 (the N/2N/2) of Section 31 and the N/2N/2 of Section 32, Township 18 South, Range 29 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the N/2N/2 of Section 31 and the N/2N/2 of Section 32 for all pools developed on 40 acre spacing within that vertical extent. The unit will be dedicated to the Pavo Macho 31/32 B2DA Fed. Com. Well No. 1H, a horizontal well with a surface location in Lot 1 of Section 31, and a terminus in the NE/4NE/4 of Section 32. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual

operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
