- 2 CHAIRMAN CATANACH: Good morning. This is
- 3 the meeting of the New Mexico Oil Conservation
- 4 Commission. My name is David Catanach, Chairman of the
- 5 Commission. Today's date is December 7th, 2017. The
- 6 time is approximately 9:20. This meeting is being
- 7 conducted in Porter Hall within the Wendell Chino State
- 8 Building. At this time I will take roll.
- 9 Will the Commissioners please introduce
- 10 themselves for the record.
- 11 COMMISSIONER MARTIN: Ed Martin, State Land
- 12 Office designee.
- 13 COMMISSIONER BALCH: Dr. Robert Balch,
- 14 designee of the Secretary of Energy, Minerals and
- 15 Natural Resources.
- 16 CHAIRMAN CATANACH: Thank you,
- 17 Commissioners.
- 18 Also present today is Mr. Bill Brancard and
- 19 Ms. Florene Davidson.
- 20 Commissioners, in your packet, you should
- 21 have an agenda for today's meeting. If you've reviewed
- 22 the agenda, do I hear a motion and second to adopt?
- 23 COMMISSIONER BALCH: I have reviewed the
- 24 agenda and move to adopt it.
- 25 COMMISSIONER MARTIN: Second.

1 CHAIRMAN CATANACH: All in favor?

- 2 (Ayes are unanimous.)
- 3 CHAIRMAN CATANACH: Motion to adopt the
- 4 agenda for today's meeting is passed.
- 5 Also in your packet is the draft minutes
- 6 for the November 9th, 2017 commission meeting.
- 7 Commissioners, do you have any changes to
- 8 the minutes and, if not, do I hear a motion and a
- 9 second?
- 10 MR. BRANCARD: Mr. Chairman, item three,
- 11 that should read "Approval of minutes of October 4th,
- 12 2017 meeting."
- 13 COMMISSIONER BALCH: That is true.
- 14 CHAIRMAN CATANACH: Approval of the minutes
- 15 for what? I'm sorry.
- 16 COMMISSIONER BALCH: Wrong date.
- 17 CHAIRMAN CATANACH: Why is that wrong? Oh,
- 18 I see. Okay. That needs to be corrected on the minutes
- 19 to reflect "October 4th, 2017." I'll correct that, and
- 20 I'll sign that.
- 21 COMMISSIONER BALCH: Move to adopt the
- 22 minutes as corrected.
- 23 CHAIRMAN CATANACH: Do I have a motion on
- 24 this to accept the minutes as corrected here today?
- 25 COMMISSIONER MARTIN: I so move.

- 1 COMMISSIONER BALCH: And second it.
- 2 CHAIRMAN CATANACH: All in favor?
- 3 (Ayes are unanimous.)
- 4 CHAIRMAN CATANACH: Motion to adopt the
- 5 minutes of the October 4th, 2017 meeting is adopted.
- 6 Couple of announcements: The following
- 7 four cases will be continued to the Commission hearing
- 8 scheduled for January 18th, Case Number 15655 and 15656,
- 9 which are applications of Black Mountain Operating, LLC
- 10 for a nonstandard oil spacing and proration unit and
- 11 compulsory pooling and an unorthodox well location, Lea
- 12 County, New Mexico; and Case Numbers 15659 and 15660,
- 13 applications of GMT Exploration Company, LLC for a
- 14 nonstandard oil spacing and proration unit and
- 15 compulsory pooling also in Lea County, New Mexico.
- 16 (Proceedings conclude, 9:28 a.m.)
- 17 (See separate record for next order of
- business, Case Number 15654.)
- 19 (9:29 a.m.)
- 20 CHAIRMAN CATANACH: Okay. Next order of
- 21 business on today's agenda is "Other Business." Do we
- 22 have any other business.
- MR. BRANCARD: No report from the
- 24 litigation front.
- 25 MS. MARKS: Mr. Chairman, I think we have

1 quite an audience here today, and I'd like to have some

- 2 public comments, if that's allowed in this open meeting.
- 3 CHAIRMAN CATANACH: Commission Attorney, is
- 4 that permissible at this time?
- 5 MR. BRANCARD: Certainly. It's an open,
- 6 public meeting.
- 7 COMMISSIONER BALCH: We've typically
- 8 limited people's comments to five minutes per person
- 9 (laughter).
- 10 MS. MARKS: Five minutes would be great.
- 11 Thank you, Commissioner Balch.
- 12 If I could start with non-OCD employees and
- 13 then start with District 1, then move to District 2 and
- 14 District 3 and then to Santa Fe, that would be greatly
- 15 appreciated.
- 16 CHAIRMAN CATANACH: I honestly don't think
- 17 the Commissioners are in a hurry to get anywhere.
- MS. BRADFUTE: Mr. Chairman, she's
- 19 referring to myself as a non-OCD employee. My name is
- 20 Jennifer Bradfute, and I'm an attorney at Modrall
- 21 Sperling.
- 22 So my career kind of starting OCD work
- 23 began as you were taking your position here as the
- 24 director at the OCD, and I heard about you from several
- 25 clients as I was both actually starting to practice

1 before the OCD and heard a world of good things about

- 2 you since. You're well respected by the industry. And
- 3 as I have worked with the Division over the past couple
- 4 of years, I see that you are with well respected by the
- 5 staff here, and people appreciate how levelheaded you've
- 6 been, how fair you've been, and how you've taken the
- 7 time to hear people out.
- 8 CHAIRMAN CATANACH: Thank you,
- 9 Ms. Bradfute. That's very nice.
- No other comments?
- MS. MARKS: If we could move on to District
- 12 1, is there anybody from District 1 who would like to
- 13 make a comment?
- 14 MR. KAUTZ: This is Paul Kautz. I've been
- 15 here 35 years now, and when I go to Santa Fe, I won't
- 16 have to be prepared to carry a hard hat with me. As I
- 17 remember when you were a hearing examiner, when you were
- 18 trying to figure out what to write about that particular
- 19 case, you would start throwing pencils into the overhead
- 20 bin, and occasionally they would fall back down to your
- 21 desk. And also you won't have to worry about me getting
- 22 you in trouble with Bill Carr anymore. But I think
- 23 you've probably been the best director since
- 24 what's-his-name was director.
- 25 CHAIRMAN CATANACH: What is his name?

1 MR. KAUTZ: And just remember, if you go

- 2 back to consulting, I have a nice, big "denied" stamp
- 3 here.
- 4 CHAIRMAN CATANACH: Thank you, Mr. Kautz.
- 5 That's wonderful.
- 6 As many of you may not know, I started my
- 7 career with OCD in District 1, and according to Charlie
- 8 up in Aztec, that's my favorite district.
- 9 MR. KAUTZ: I was just stating facts. They
- 10 do make the news quite often.
- 11 MR. BAYLISS: So is there any more from
- 12 District 1?
- MS. SHARP: Good morning, David. This is
- 14 Karen.
- 15 CHAIRMAN CATANACH: Good morning, Karen.
- 16 MS. SHARP: Just wanted you to know that we
- 17 took a vote, and your retirement is rescinded, and don't
- 18 wait seven years to come back. Good luck.
- 19 CHAIRMAN CATANACH: Okay. Thank you,
- 20 Karen. It's been a pleasure working with you guys in
- 21 District 1 and in all the districts.
- 22 (Laughter.)
- MR. BAYLISS: How about District 2?
- MR. BRATCHER: Yes. This is Mike.
- I need to set this up a little bit. I

1 mean, I heard this was a roast, so I'm going to roast a

- 2 little.
- When I first came to work with OCD,
- 4 Mr. Catanach was one of the local Santa Fe faces. Me
- 5 being just a lowly field inspector, I didn't get to see
- 6 much of the Santa Fe folks. But in 2004, Mike
- 7 Stubblefield retired, and he was the environmental guy
- 8 for District 2. Back then, environmental stuff for the
- 9 OCD was kind of in its infancy. Mike came in one day
- 10 and had a box of C-141s and remediation plans and I
- 11 don't know what all. He set it on my desk, and he said,
- 12 Here, you're the new environmental guy. I said, Okay.
- 13 I still have that box today sitting here under the desk.
- 14 I never got to it. I've always been at a deficit.
- 15 Throughout more than a decade that I've
- 16 done this out east, I've been involved in what I
- 17 lovingly refer to as the chloride wars. The OCD wants
- 18 to regulate chlorides, but we've been reluctant to throw
- 19 anything out there. So it's been the chloride wars the
- 20 whole time I've been here. And I thought it would be --
- 21 this is falling on December 7th, which is the 76th
- 22 anniversary of Pearl Harbor.
- Being a Navy veteran, maybe I can come off
- 24 without being too disrespectful to that. December 7th,
- 25 1941, the first wave hit Pearl Harbor at 7:55 a.m. --

1 (Poor phone/video conference transmittal.)

- 2 MR. BRATCHER: -- time and lasted until
- 3 about 9:00. We lost more than 2,400 American sailors,
- 4 soldiers and civilians, along with 1,000 wounded.
- 5 Twenty naval vessels were sunk. Greater than 300
- 6 airplanes were lost. Franklin D. Roosevelt said, "It's
- 7 a date which will live in infamy."
- 8 The reason I bring that up is that started
- 9 a war, and it relates back to the chloride wars. And,
- 10 you know, David, I appreciate everything you've done.
- 11 You've done a lot. You've tried to do a lot. You've
- 12 kind of led us into what we hope is the final battle on
- 13 the chloride wars with the upcoming -- upcoming rule.
- 14 But naval vessels are known to have a lot of rats and
- 15 mice and stuff on there, and when they start -- out,
- 16 that's the first thing that happens, is the rats and
- 17 mice jump ship.
- 18 (Laughter.)
- 19 MR. BRATCHER: So I appreciate you for
- 20 starting this final battle, but why are you jumping
- 21 ship?
- (Laughter.)
- MR. GRISWOLD: God bless you, Mike
- 24 Bratcher.
- MR. BRATCHER: Silence right there.

- 1 (Laughter.)
- 2 CHAIRMAN CATANACH: I don't have an answer
- 3 to that, Mike. I've been here 28 years total, and I
- 4 think it's about time to get going on something else.
- 5 So that's my answer.
- 6 MR. BRATCHER: Yeah. I wish you the best.
- 7 I just thought it was befitting of the day to make that
- 8 analogy.
- 9 CHAIRMAN CATANACH: Thanks.
- 10 (Laughter.)
- 11 CHAIRMAN CATANACH: "Jumping ship."
- MR. BAYLISS: Anything else from District
- 13 2?
- MS. TULK: David, this is Laura.
- MR. BAYLISS: I thought so.
- 16 CHAIRMAN CATANACH: You can't keep Laura
- 17 down. She's always got something to say.
- MS. TULK: No, you don't have anything on
- 19 your nose.
- 20 It's nice meeting you. Thanks for taking
- 21 the time, you know, your visits. They were nice. And
- 22 you took the time to visit each one of us, not all the
- 23 time, but, you know. I'll never forget our first
- 24 meeting. I think Griswold brought you down, and I just
- 25 had to have -- I don't know, Daniel. I've given you

1 guys almonds, and I'm like the mom, you know, make sure

- 2 you-all have a little snack on the way home because of
- 3 the budget and all. Anyway, I just remember you telling
- 4 me that you sure were glad because Griswold was going to
- 5 feed you a chimichanga, I guess, in Vaughan.
- 6 CHAIRMAN CATANACH: Griswold did feed me
- 7 (laughter).
- 8 MS. TULK: You said, I'm going to save this
- 9 snack Laura gave me, and I'll be good until I get home.
- 10 CHAIRMAN CATANACH: I appreciated it.
- 11 Laura, I appreciated it. I did get a chimichanga from
- 12 Mr. Griswold at Allsup's.
- MS. TULK: Oh, you did?
- Okay. Well, anyway, if you get bored, come
- 15 help me scan some logs.
- 16 CHAIRMAN CATANACH: I'll do that. Thank
- 17 you, Laura.
- MS. TULK: Thank you.
- 19 MR. BAYLISS: So do we have anything else
- 20 from District 2?
- 21 Well, let's go to the northwest. How about
- 22 District 3?
- 23 CHAIRMAN CATANACH: My favorite district,
- 24 District 3.
- MR. PERRIN: Well, David, I've only been

1 here about 26 years, so you're an old-timer. District 1

- 2 has always stated to be your favorite, but we know the
- 3 truth.
- 4 MS. TULK: No. His favorite was District
- 5 2. He kept telling us that.
- 6 MR. PERRIN: This is your second
- 7 retirement, so we want to see if this one is going to be
- 8 for real and in writing. We've watched you retire twice
- 9 now. David, do you want to share with us what you're
- 10 going to do?
- 11 CHAIRMAN CATANACH: I bought a skateboard,
- 12 and I'm going to hang out at the skateboard park for a
- 13 while here in Santa Fe. After that, I'm not so sure.
- 14 (Laughter.)
- 15 COMMISSIONER BALCH: After that, he'll be
- 16 in the emergency room.
- 17 CHAIRMAN CATANACH: I'll spend some time in
- 18 the hospital after that.
- 19 (Laughter.)
- 20 MR. PERRIN: We'll know to stack up on some
- 21 get well cards.
- 22 CHAIRMAN CATANACH: I really don't know,
- 23 Charlie. I know I will be doing something and maybe
- 24 doing some consulting again, but I'm going to take a
- 25 little time just to unwind.

- 1 MR. PERRIN: Well, we'd like to
- 2 congratulate you on your retirement and let you know
- 3 that we look forward to working for you -- or working
- 4 with you in the future. I think it's interesting to
- 5 know that District 1 is not the only one with a big
- 6 "deny" stamp -- or complete, correct and timely each and
- 7 every time.
- 8 CHAIRMAN CATANACH: Well, you never know.
- 9 I may be back, Charlie, so careful with that "denied"
- 10 stamp.
- MR. PERRIN: Maybe that ship-jumping the
- 12 second time will bring you back a third time, and then
- 13 you can get your stuff finished up.
- 14 CHAIRMAN CATANACH: Okay.
- 15 MR. PERRIN: The ship-jumping part. We
- 16 wish you well.
- 17 CHAIRMAN CATANACH: Thank you, Charlie.
- Okay. We done?
- 19 MR. BAYLISS: He's hoping that District 3
- 20 is done. This should be encouragement for more.
- 21 MR. PERRIN: We're done for now.
- 22 CHAIRMAN CATANACH: Thanks. Cory H.
- MS. VERMERSCH: Director Catanach,
- 24 complete, correct and timely.
- 25 CHAIRMAN CATANACH: Was that Amy?

- 1 MR. BAYLISS: Amy said that.
- 2 CHAIRMAN CATANACH: Thank you, Amy.
- 3 MS. VERMERSCH: When you go work for
- 4 industry, you might get those little denied stickers.
- 5 CHAIRMAN CATANACH: I could be back here,
- 6 Amy. You better be careful.
- 7 (Laughter.)
- 8 MR. PERRIN: He's already threatened to
- 9 come back. He may be our boss.
- 10 CHAIRMAN CATANACH: If I came back a third
- 11 time, the people at PERA would think I was really nuts.
- MR. PERRIN: I think that's everything from
- 13 District 3.
- MR. BAYLISS: Okay.
- 15 CHAIRMAN CATANACH: Thanks, guys. So --
- MR. BAYLISS: There are people here laying
- 17 in wait.
- 18 MR. BROOKS: The record will reflect
- 19 District 4 is unrepresented.
- 20 (Laughter.)
- 21 CHAIRMAN CATANACH: I should have sent more
- 22 of you away today. We sent Will Jones to a BLM training
- 23 session. So --
- MR. GRISWOLD: For the record, I'm Jim
- 25 Griswold, the Environmental Bureau chief of the

1 Division, maybe the last Environmental Bureau chief the

- 2 Division's ever had. And I know we'll get a chance over
- 3 the remaining couple of weeks to say goodbye again, but
- 4 thanks, Dave. And I would hope but I know it's not true
- 5 that the work at the Environmental Bureau didn't have
- 6 anything to do with you deciding to retire, but that's
- 7 not the case. But it's been a pleasure having you --
- 8 the three Division directors that I've served for the
- 9 last ten years, far and away, you're the best to work
- 10 with.
- 11 CHAIRMAN CATANACH: Thanks, Jim. I
- 12 appreciate it. And I wish for once you would have come
- in and given me some good news in the morning.
- 14 MR. GRISWOLD: September production is over
- 15 15 million barrels, an all-time high.
- 16 MR. BILLINGS: I'm Brad Billings. I
- 17 haven't known you that long, but it has been a pleasure.
- 18 I understand this is your second retirement, and you're
- 19 already indicating you might do three or more. Your
- 20 presence is going to be pretty minimal because we're not
- 21 really sure when you're leaving. So that's all. Thank
- 22 you.
- 23 (Laughter.)
- 24 CHAIRMAN CATANACH: Thank you, Bradford.
- MR. SANCHEZ: Daniel Sanchez, Compliance

- 1 and Enforcement manager. And I have to copy a little
- 2 bit on what Jim said. Of the three that I've worked for
- 3 the last 14 years, you've definitely been the easiest
- 4 one to work for. Some of the piles of paper that I take
- 5 over to your desk to have you sign, I've been pretty
- 6 lucky that you've read through them. I'll try that with
- 7 the next director. Well, I guess. But it really has
- 8 been a pleasure working for you, and I wish you the
- 9 best.
- 10 CHAIRMAN CATANACH: Thanks, Daniel. I
- 11 enjoyed working with you. And I did read those
- 12 documents, for the record.
- MR. SANCHEZ: Damn it.
- 14 CHAIRMAN CATANACH: I'm a speed reader.
- MR. BROOKS: Well, my remarks won't be as
- 16 long as they usually are.
- 17 (Applause, laughter.)
- 18 COMMISSIONER BALCH: I'm going to set the
- 19 five-minute timer.
- 20 MR. BROOKS: The statement was made by, I
- 21 think, Bratcher that you were the best director since
- 22 what's-his-name, and his name is -- my only guess is
- 23 that his name is Bill LeMay. Which I can attest to the
- others in between, but I don't date back to Bill LeMay.
- 25 So I would say you're the best since Bill LeMay.

1 Of course, when I came here, there was a

- 2 lot of talk about Catanach and Stogner among the
- 3 employees, and I had the feeling -- I got the impression
- 4 that they were perceived as sort of a duplicate
- 5 personality like -- like Rosencrantz and Guildenstern or
- 6 Haldeman and Ehrlichman --
- 7 (Laughter.)
- 8 MR. BROOKS: -- but I soon found out there
- 9 was a marked difference because Catanach was uniformly
- 10 professional and courteous, and Mr. Stogner's
- 11 professionalism was occasionally tinged with episodes of
- 12 temper.
- 13 Anyway, Catanach was here, I think, for six
- 14 or seven years before I -- before he retired -- for the
- 15 time that I was here before he left and retired. And
- 16 then when you came back, I had retired. And now I've
- 17 been here for two years, and we've been here together
- 18 since we both came back. And the last time he retired,
- 19 I got his office. It doesn't look like this is going to
- 20 happen this time.
- 21 (Laughter.)
- 22 MR. BROOKS: And he has left me with a
- 23 horizontal well rule in midstream. And another comment
- 24 Bratcher made when he was talking about the Navy, he
- 25 said something about the Japanese attack on Pearl

- 1 Harbor, that the first wave came in at 7:00 and
- 2 created -- in the morning and created all sorts of
- 3 havoc, then they left at 9:00. And I thought maybe he
- 4 was drawing some analogy there to David Catanach, but
- 5 since I'm never here before 8:30, I can't attest to that
- 6 personally.
- 7 (Laughter.)
- 8 MR. BROOKS: Anyway, David, we appreciate
- 9 your service. And we wish you would withdraw your
- 10 resignation, your retirement.
- 11 CHAIRMAN CATANACH: Well, thank you.
- 12 Mr. Brooks. I'm usually here at 6:30, by the way,
- 13 instead of 7:00.
- MR. BROOKS: Oh. Oh.
- 15 CHAIRMAN CATANACH: And I'd just like to
- 16 say that the stories you heard about Stogner and
- 17 Catanach were probably not true. There are a lot of
- 18 stories going around. But we were really good employees
- 19 and respected management.
- 20 MR. BROOKS: Well, I know you were. I was
- 21 here for several years after -- I was here for several
- 22 years after you left, and I also had a considerable
- 23 opportunity to observe what I assume were sources of
- 24 some of those stories.
- 25 CHAIRMAN CATANACH: Not true. Most of them

- 1 are not true. Exaggeration.
- 2 MR. WARNELL: Terry Warnell, with the State
- 3 Land Office --
- 4 CHAIRMAN CATANACH: Good morning,
- 5 Mr. Warnell.
- 6 MR. WARNELL: -- ex-OCD-er. I started
- 7 working at the OCD ten years ago, and kind of like what
- 8 David was saying -- or what Mr. Brooks was saying, David
- 9 wasn't here then. He had already retired. I had heard
- 10 a lot of stories, a lot of good things about David, and
- 11 then I got to know him, and I figured out that wasn't
- 12 true.
- 13 (Laughter.)
- MR. WARNELL: I've enjoyed working with
- 15 you, David, and wish you the very best.
- 16 CHAIRMAN CATANACH: Thank you, Terry.
- 17 MR. McMILLAN: Mike McMillan, engineering.
- 18 My biggest regret is that you never gave
- 19 the OCD the opportunity to give a presentation about
- 20 working harder but not smarter.
- 21 (Laughter.)
- 22 CHAIRMAN CATANACH: I'm glad you brought
- 23 that up, Mr. McMillan. I still have three weeks left,
- 24 right? I know a perfect person to come in and give you
- 25 guys a full-day seminar on that, so I will contact

- 1 Mr. Ezeanyim.
- 2 MR. McMILLAN: And I had to testify before
- 3 the OCD, and I had heard horror stories about it, about
- 4 the examiners. And I was a witness before you, and it
- 5 was true.
- 6 (Laughter.)
- 7 MR. BROOKS: Next time we'll bring Michael
- 8 Feldewert in.
- 9 CHAIRMAN CATANACH: Thanks, Mike.
- 10 MR. HERRMANN: Mr. Catanach -- or Director
- 11 Catanach, Keith Herrmann representing the Compliance and
- 12 Enforcement Bureau.
- I want to congratulate you on finally
- 14 getting your picture on the wall. Not only that, but
- 15 they are level, and from what I can tell, actually
- 16 equally spaced.
- 17 (Laughter.)
- 18 CHAIRMAN CATANACH: We thank Mr. Goetze,
- 19 who is responsible for that.
- MR. GOETZE: And Mr. Leonard.
- 21 CHAIRMAN CATANACH: Mr. Leonard -- Mr.
- 22 Lowe, Mr. Goetze.
- MR. GOETZE: Mr. Lowe.
- 24 Phil Goetze, Engineering Bureau.
- The esteemed attorney, Mr. Brooks, has

- 1 brought to our attention that the position of the
- 2 director has many hats to wear as a director, and this
- 3 was brought to the attention of the Governor's Office.
- 4 May I approach the table, please?
- 5 CHAIRMAN CATANACH: I'm not sure.
- 6 (Laughter.)
- 7 COMMISSIONER BALCH: Can we have a vote on
- 8 that?
- 9 MR. GOETZE: Please, if you would, remove
- 10 the device (indicating).
- This (indicating) was flown in from the
- 12 fourth floor. Each panel represents a part of your job
- 13 description.
- 14 (Laughter.)
- MR. GOETZE: We can start with the star.
- 16 That would be the commitment to a team that has a hard
- 17 time winning -- Mr. Sanchez. Of course, the director is
- 18 for your position that you hold now, kind of, and is, of
- 19 course, very black and white. And then, of course,
- 20 there is the commissioner, and that's the most -- how do
- 21 we say it -- fluctuate and most dynamic position that
- 22 you hold. And then the fourth panel is, of course,
- 23 dedication to your future, which is a retirement going
- 24 and fishing and enjoying your life. But wear it in good
- 25 health, and remind you of all these fantastic influences

- 1 and pride of work that you've done.
- 2 MR. GRISWOLD: Put it on.
- MR. GOETZE: And it has been an honor and
- 4 privilege to work with you.
- 5 (Special handcrafted, flown-in-from-the-
- fourth floor, four-panel hat presented to
- 7 Director Catanach.)
- 8 CHAIRMAN CATANACH: That's very unique, and
- 9 I will treasure that always.
- 10 MS. WOJAHN: Director Catanach, as you
- 11 know, I'm Beth Wojahn. I'm the P&IP [sic] for the
- 12 Department.
- 13 (Poor phone/video conference transmittal.)
- 14 MS. WOJAHN: And on behalf of Secretary
- 15 McQueen and Deputy Secretary Matthias Sayer, thank you
- 16 for all you've done. Certainly, they've only been here
- 17 for a year, but you and your team have been here a lot
- 18 longer. And I just want to say from my heart, I really
- 19 appreciate all you've done for OCD, and we do realize
- 20 that you have a good team, and that's very important.
- 21 And we will try and do our best to wish you the best in
- 22 your retirement.
- 23 CHAIRMAN CATANACH: Thank you, Beth, very
- 24 much. I enjoyed totally working with you and the
- 25 Secretary and the Deputy Secretary for the year.

1 MS. MARKS: Dr. Catanach, Allison Marks,

- 2 Deputy Director of the OCD.
- I think it's quite telling that it took
- 4 your last commission hearing to put your picture finally
- 5 on the wall. It's a reflection of you as a person.
- 6 You're possibly the most humble person I have ever
- 7 worked for. And getting all of the districts here for
- 8 your last meeting is very meaningful. I know how much
- 9 the districts mean to you, and you have done everything
- 10 to reach out and include the districts' staff and make
- 11 them feel important. And I know how important the
- 12 districts' staff are to you. You would have gone to
- 13 each district office every single week if you could
- 14 have.
- 15 And everyone at Aztec, Artesia and Hobbs --
- 16 the fan favorite -- he would have gone to see you every
- 17 single week and I do know that. He loves you guys
- 18 probably more than everyone here in Santa Fe. And I
- 19 think Director Catanach has hopefully set a foundation
- 20 for the next director to make the districts' staff be
- 21 the real heart and soul of the Division and make the
- 22 districts' staff really all feel as though they are part
- of one OCD and not just a Santa Fe OCD.
- 24 And Director Catanach won't want me to say
- 25 this, but he has beaten himself up probably on a weekly

1 basis for not feeling as though he has done enough, but

- 2 I think he has done enough as he could with budget
- 3 constraints and staffing levels. But his heart has been
- 4 in the right place for the past three years, and I
- 5 really appreciate everything he has done.
- 6 And all the districts' staff and Santa Fe
- 7 has come together to get a pretty cool present here that
- 8 we have for you. We have a cool fly box here. It says,
- 9 "You're pretty fly for a state petroleum engineer."
- 10 Some flies in here and a gift card so you can -- it's
- 11 pretty cool. We have the first snow day of the year, so
- 12 you can get some skis or a new mountain bike. And
- 13 that's from all the districts' staff and everyone here
- 14 in Santa Fe. And we will really miss you.
- MR. GOETZE: Don't cry.
- 16 CHAIRMAN CATANACH: I'm not going to cry,
- 17 Mr. Goetze.
- MS. MARKS: And your sense of humor.
- 19 CHAIRMAN CATANACH: I'd just like to say,
- 20 Ms. Marks, one of the ways that this job has been
- 21 easier, at least for the past year, was because you came
- 22 to us, and you tremendously helped me in my job, and I
- 23 really appreciate everything you've done this year. So
- 24 I want to thank you personally.
- MS. MARKS: Thank you.

- 1 CHAIRMAN CATANACH: Is that it?
- 2 MR. BAYLISS: You've got the tennis racket.
- 3 You can bang it.
- 4 CHAIRMAN CATANACH: I'd just like to say --
- 5 I mean, this is -- I've been here 28 years, and this is
- 6 the only thing that I've ever known. The Division is
- 7 home to me. It's -- I've worked with so many wonderful
- 8 people over the years, and truly they're all dedicated
- 9 professionals, and I think that that's -- when I leave
- 10 this job, that's what I'm going to miss the most
- absolutely, is the people that I've worked with, the
- 12 people that I currently work with. And I just want to
- 13 thank everybody in the Division for making this job
- 14 easier over the past three years. Well, sometimes.
- 15 Sometimes it is difficult. We've gone through some very
- 16 difficult times. And I just again want to thank
- 17 everybody for being dedicated and professional and
- 18 helping me out. So thank you-all.
- Okay. Any other business?
- 20 And I wish to thank the Commissioners.
- 21 I've enjoyed being on the Commission for three years,
- 22 and I know we've had some really interesting cases over
- 23 that period of time, and we've come through it okay.
- 24 And I wish you well in the horizontal well rule hearing
- 25 and the spill rule hearing that will be up shortly,

1 probably the first quarter of this next year. And I

- 2 know you guys will do a wonderful job, and I wish you
- 3 well.
- 4 COMMISSIONER BALCH: I don't know about Ed,
- 5 but I'm retiring next week.
- 6 COMMISSIONER MARTIN: I'm thinking about it
- 7 myself.
- 8 (Laughter.)
- 9 CHAIRMAN CATANACH: And thank you,
- 10 Mr. Brancard, for all the help you've given me and the
- 11 Commission over the years. I really appreciate your
- 12 effort.
- MR. BRANCARD: Your ability to run and
- 14 handle a hearing makes my job so much easier. So I
- 15 appreciate it.
- 16 CHAIRMAN CATANACH: Not at first. I
- 17 remember I had never done a commission hearing, and I
- 18 was very nervous. I had done an examiner hearing, but I
- 19 had never done a commissioner hearing. So I was very
- 20 nervous, so you helped me through the first few.
- 21 MR. BRANCARD: You know how to handle a
- 22 racket or a gavel.
- 23 CHAIRMAN CATANACH: And thank you, Florene.
- 24 She's a wonderful person, who has been here
- 25 for 55 years, and she is one of the ones I will miss the

- 1 most.
- 2 MS. DAVIDSON: I just wanted to say I
- 3 worked with David --
- 4 All of your time was in Santa Fe, right?
- 5 CHAIRMAN CATANACH: Yes, ma'am.
- 6 MS. DAVIDSON: -- since he was just a young
- 7 boy --
- 8 (Laughter.)
- 9 MS. DAVIDSON: -- sometimes a bratty boy.
- 10 And the stories about Stogner and Catanach, not all of
- 11 them -- some of them are true, yes.
- 12 (Laughter.)
- MS. DAVIDSON: But I've enjoyed working
- 14 with you. It was hard to go from working with you to
- 15 working for you, to taking -- but you didn't give me too
- 16 many orders, so that was good. I've enjoyed all my time
- 17 with you, David. You will be missed.
- 18 CHAIRMAN CATANACH: Thank you, Florene.
- I can tell you with regards to Mr. Martin
- 20 sitting next to me, there was a time we worked together
- 21 under Commissioner -- I mean under Director --
- 22 COMMISSIONER MARTIN: What's-his-name.
- 23 (Laughter.)
- 24 CHAIRMAN CATANACH: -- what's-his-name.
- 25 And I think I was nearing the end of my career the first

Page 28 time, the 25 years, and I might have had a little bit of an attitude. And the director came into my office one 2 day and told me, I don't want you to talk to Ed Martin 3 anymore; you're having a bad influence on him. And 4 that's a true story. So I promptly went over to Ed's 5 6 office and talked to him as much as I could. 7 (Laughter.) 8 COMMISSIONER MARTIN: I was traumatized. 9 CHAIRMAN CATANACH: Again, thank you very much. And I appreciate this ceremony, and it was 10 11 memorable and wonderful. Thank you.
