2 CHAIRMAN CATANACH: The next order of
3 business is the disposition of Case Number 15654, which
4 was the application of Mesquite SWD, Inc. to amend
5 approvals for saltwater disposal wells, Lea and Eddy
6 Counties.

7 Commissioners, this case was heard at the
8 November 9th meeting and deliberations were conducted,
9 and the Commission determined that the application in
10 that case should be approved.

11 Prior to the hearing, you were provided a
12 draft order in this case. At this time I will ask you
13 if you have any changes to the draft order.

14 COMMISSIONER BALCH: I have no further
15 changes to the draft order.

16 CHAIRMAN CATANACH: Mr. Martin?

17 COMMISSIONER MARTIN: I have no additional
18 changes.

19 CHAIRMAN CATANACH: I will mention that
20 subsequent to the November 9th hearing, it was
21 discovered that one of the wells that was the subject of
22 that case, the Gnome East SWD No. 1, had been moved to a
23 new well location. This well will have to be
24 re-permitted for produced water injection, and
25 subsequently the well has been dropped from

1 consideration in this order.

2 So at this time, do I hear a motion to
3 adopt the order in Case Number 15654?

4 COMMISSIONER BALCH: Move to adopt the
5 order as amended.

6 COMMISSIONER MARTIN: Second.

7 CHAIRMAN CATANACH: All in favor?

8 (Ayes are unanimous.)

9 CHAIRMAN CATANACH: Motion to adopt Order
10 Number R-14392-A in Case Number 15654 is passed.
