21 And for those that we didn't receive a
22 green card back from, that we received a
23 return-to-sender, we published notice, and that is
24 Exhibit 12.

25 Between the green cards and the

1 publication, we have served notice upon all of the
2 working interest owners, offset operators and now
3 overriding royalty interest owners listed in Exhibit A
4 to our Exhibit 11, if that makes sense. That was a lot.

5 I would move the admission at this time of
6 Exhibits 11 and 12 and ask that the case be taken under
7 advisement.

8 EXAMINER JONES: Any objection from
9 OneEnergy?

10 MS. KESSLER: No objections.

11 EXAMINER JONES: Exhibits 11 and 12 are
