2 EXAMINER JONES: Let's go on the record and
3 call Docket Number 4-18. This is an amended docket. I
4 hope you checked the Web site after Monday because it
5 got changed after Monday morning. So we have 39 cases
6 listed.

7 So this is the docket of the Examiner
8 Hearing, Thursday, January 25th, 2018. I'm William V.
9 Jones.

10 This is Leonard Lowe (indicating). We're
11 both engineers, so we'll be a little shortsighted this
12 morning. And we have David Brooks to keep us all
13 straight as our counsel.

14 Let's first call the continuances and
15 dismissals.

16 On page 2, all of -- page 2, Case 15947 is
17 continued to February the 8th. Case 15948 is continued
18 to February 8th. Case 15927 is continued to February
19 8th. Case Number 15928 is continued to February 8th.

20 Page 3, Case 15929 is continued to February
21 8th.

22 Good luck to everybody on February 8th.

23 And then all of the Ascent cases are
24 continued to February 8th. Those are Case Numbers
25 15949, 15950, 15951 and 15952. And Case 15916 is

1 continued to February 22nd.

2 Page 4, Case 15917 is continued to February
3 22nd. Case 15918 is continued to February 22nd. Case
4 15897 is continued to March 22nd. Case 15898 is
5 continued to March 22nd, and Case 15932 is continued to
6 February 8th.

7 And on page 5, Case 15935 is continued to
8 February 8th. Case 15933 is continued to February 8th.

9 On page 6, Case 15872 is dismissed. I
10 think we had already discussed that one, but we are just
11 making sure it's dismissed now.

12 And Case 15888 is continued to May the
13 31st.

14 And on the last page, page 9, Case 15893 is
15 dismissed.

16 Did I miss anything or any changes?

17 Okay. Well, we have several cases that may
18 just be a submittal of affidavits, so let's finish up
19 those cases.

20 Let's jump to the back of the docket real
21 quick and take care of the Chisholm-Great Western cases.
