**MOTION FOR A CONTINUANCE**

Mewbourne Oil Company ("Mewbourne") moves for a continuance of the above matters, and in support thereof, states:

1. These cases involve competing pooling applications in Sections 6 and Section 7, Township 24 South, Range 29 East, NMPM.
2. The cases are set for a special hearing on Tuesday, February 27, 2018.
3. Mewbourne is (internally) discussing options to resolve this matter without the need for a contested hearing.
4. Mewbourne requests that the hearing be continued to March 22, 2018, with the intention that in the interim the parties will discuss another special hearing date. Counsel for RSC Resources, L.P. ("RSC") and Mewbourne have discussed hearing dates in the second half of March, and March 20<sup>th</sup> may be a workable date.
5. RSC, Chevron U.S.A. Inc., and COG Operating LLC agree to a continuance. Counsel for Mewbourne has not yet received a response from counsel for Devon Energy Production Company, L.P. regarding a continuance.

WHEREFORE, Mewbourne requests that the above cases be continued to March 22<sup>nd</sup> docket, with the intent that the parties will consult on another special hearing date.


