MOTION FOR CONTINUANCE

OXY USA, Inc. ("OXY") moves the Division for a sixty-day continuance in these consolidated cases. In support of this motion, OXY states as follows:

1. OXY owns a contractual working interest of approximately 12.9 percent in Lots 1-7 and the E/2 SW/4 (358.65 gross acres, more or less) of Section 6, T24S, R29E, Eddy County, as to all depths excluding the gas rights in the Atoka formation.
2. Despite this ownership interest, OXY has not received well proposals for the six wells RSC Resources, LP proposes to drill and dedicate to the W/2 of Section 6.
3. OXY has not had the opportunity to review and evaluate RSC's well proposals and estimated well costs.
4. These cases are currently set to be heard on a special hearing docket on Tuesday, March 20, 2018.

5. Counsel for OXY has conferred with counsel for RSC Resources, the applicant in Case No. 15968. RSC opposes the motion.

6. Mewbourne Oil Company, the applicant in Case Nos. 15913 and 15914, and COG Operating LLC and Chevron do not oppose the motion. Counsel was unable to determine Devon Energy Production Company, LLC's position on the motion.

WHEREFORE, OXY requests that the hearing on these cases be continued sixty days until a date mutually agreeable to the Division and the parties.
