COG Operating LLC seeks and order (1) creating a 320-acre, more or less, oil spacing and proration unit in the Bone Spring formation, comprised of the E/2 E/2 of Sections 22 and 27, Township 23 South, Range 32 East, NMPM, Lea County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation underlying this proposed non-standard spacing and proration unit as the project area for the proposed **Avion Federal Com Well No. 301H**, which will be drilled from the surface location in the NE/4 NE/4 (Unit A) of Section 22 to a

bottomhole location in the SE/4 SE/4 (Unit P) of Section 27. The completed interval for the well will comply with the Division's setback requirements.


