- 2 EXAMINER JONES: Let's go back on the
- 3 record and call Case Number 15602, re-opened,
- 4 application of Mewbourne Oil Company to re-open Case
- 5 Number 15602 for a nonstandard oil spacing and proration
- 6 unit and compulsory pooling, Lea County, New Mexico.
- 7 Call for appearances.
- 8 MR. BRUCE: Mr. Examiner, Jim Bruce
- 9 representing the Applicant, and one witness.
- 10 EXAMINER JONES: Will the witness please
- 11 stand and the court reporter swear the witness?
- 12 MITCH ROBB,
- after having been first duly sworn under oath, was
- 14 questioned and testified as follows:
- 15 DIRECT EXAMINATION
- 16 BY MR. BRUCE:
- 17 Q. Would you please state your name?
- 18 A. Mitch Robb.
- 19 Q. Who do you work for and in what capacity?
- 20 A. Mewbourne Oil Company as a landman.
- 21 Q. Have you previously testified before the
- 22 Division?
- 23 A. Yes, I have.
- Q. And were your credentials as an expert
- 25 petroleum landman accepted as a matter of record?

- 1 A. Yes, they were.
- 2 Q. And are you familiar with the land matters
- 3 involved in this application?
- 4 A. Yes, I am.
- 5 MR. BRUCE: Mr. Examiner, I'd tender
- 6 Mr. Robb as an expert petroleum engineer -- I mean
- 7 petroleum landman.
- 8 EXAMINER JONES: He is so qualified.
- 9 Q. (BY MR. BRUCE) Mr. Robb, could you identify
- 10 Exhibit 1 and describe what Mewbourne seeks in this
- 11 case?
- 12 A. Yes. Exhibit 1 is a Midland Map of the east
- 13 half -- highlighted as the east half of the west half of
- 14 Section 15 of Township 23 South, Range 34 East, Lea
- 15 County, New Mexico. It also shows the wellbore of the
- 16 Pronghorn 15 B3CN Fed Com #1H. It's in the Antelope
- 17 Ridge; Bone Spring --- Antelope Ridge, West; Bone Spring
- 18 Pool.
- 19 Q. And there was a prior order in this case,
- 20 correct?
- 21 A. Yes.
- Q. And that established the nonstandard unit?
- 23 A. Yes.
- 24 Q. And it also force pooled a number of people, I
- 25 **believe?**

- 1 A. Yes, that's true.
- 2 O. Are you back to force pooling some people who
- 3 were omitted by -- just mistakenly omitted from the
- 4 pooling list?
- 5 A. Yes. That's what we're doing.
- 6 Q. Could you identify Exhibit 2?
- 7 A. Exhibit 2 is our revised tract ownership for
- 8 the Pronghorn well. And the companies with the
- 9 asterisks next to them are the parties we seek to pool,
- 10 being Landis Drilling Company, Black & Gold Resources,
- 11 LLC, Charles C. Albright III, Trustee, and the
- 12 Rutherford Family 1970 Trust.
- 13 O. What is Exhibit 3?
- 14 A. Exhibit 3 is our summary of communications with
- 15 all of the parties we seek to pool.
- 16 Q. I notice on this list that with respect to
- 17 Landis Drilling and Mr. Albright, as trustee, you
- weren't able to get in touch with them, correct?
- 19 A. That's correct.
- Q. What did you -- what did Mewbourne do to try to
- 21 locate these two entities?
- 22 A. We searched our internal records. We searched
- 23 LexisNexis, the most recent addresses in the courthouse,
- 24 in the county records, and just the white pages and
- 25 general Internet searches.

- 1 Q. And then with respect to Black & Gold
- Resources, LLC and the Rutherford Family Trust, you were
- 3 able to get in contact with them?
- 4 A. That's correct.
- Q. And does Exhibit 3 contain a summary of your
- 6 contacts, plus the various letters sent to them?
- 7 A. Yes.
- 8 Q. Have they indicated an interest in joining in
- 9 the well or --
- 10 A. Black & Gold has. We've been discussing the
- 11 JOA with them, but we just haven't received a signed --
- 12 Q. In your opinion, has Mewbourne made a
- good-faith effort to obtain the voluntary joinder of the
- 14 interest owners in the well?
- 15 A. Yes, we have.
- 16 Q. What is Exhibit 4?
- 17 A. Exhibit 4 is the AFE for Pronghorn 15 B3CN Fed
- 18 Com #1H -- all the parties.
- 19 Q. And what is its cost?
- 20 A. Dry-hole cost is \$3,009,600. Total well cost
- 21 is \$6,496,000.
- 22 O. And are these costs in line with the cost of
- other wells of this type in this area of New Mexico?
- 24 A. Yes.
- 25 Q. Do you request that Mewbourne be appointed

- 1 operator of the well?
- 2 A. Yes, we do.
- 3 Q. And what do you request as the overhead and
- 4 supervision rates?
- 5 A. 7,500 a month for drilling and 750 for
- 6 producing.
- 7 Q. And are these amounts equivalent to those
- 8 normally charged by Mewbourne and other operators in
- 9 this area for wells of this type?
- 10 A. Yes.
- 11 Q. Do you request that the rates be periodically
- 12 adjusted as provided by the COPAS accounting procedure?
- 13 A. Yes, we do.
- 14 Q. And do you request the maximum cost plus risk
- 15 charge for any interest owner who goes nonconsent in the
- 16 well?
- 17 A. Yes, we do.
- 18 MR. BRUCE: Mr. Examiner, I did send out
- 19 notice, and I did get a couple of green cards back.
- 20 Obviously, there were a couple of unlocatable owners.
- 21 Just like Mr. Feldewert earlier, I submitted an
- 22 affidavit -- or a Notice of Publication timely to the
- 23 newspaper, but they didn't get it out until too late.
- 24 So I would request that this matter be continued to the
- 25 May 3rd hearing to complete the notice requirements.

- 1 EXAMINER JONES: Okay.
- Q. (BY MR. BRUCE) Were Exhibits 1 through 4
- 3 prepared by you or under your supervision or compiled
- 4 from company business records?
- 5 A. Yes, they were.
- 6 Q. In your opinion, is the granting of this
- 7 application in the interest of conservation and the
- 8 prevention of waste?
- 9 A. Yes, it is.
- 10 MR. BRUCE: Mr. Examiner, I move the
- 11 admission of Exhibits 1 through 4.
- 12 EXAMINER JONES: Exhibits 1 through 4 are
- 13 admitted.
- 14 (Mewbourne Oil Company Exhibit Numbers 1
- 15 through 4 are offered and admitted into
- 16 evidence.)
- MR. BRUCE: I have no further questions of
- 18 the witness.
- 19 CROSS-EXAMINATION
- 20 BY EXAMINER BROOKS:
- 21 Q. You probably already answered these questions,
- 22 but I'll ask them again just because -- just because of
- 23 old age. Mine, not yours, obviously.
- Who are you pooling -- who are you trying
- 25 to pool in this second proceeding?

1 A. So on Exhibit 2, the companies have an asterisk

- 2 next to their name on the left side.
- Q. Landis Drilling --
- 4 A. Yeah, Landis.
- 5 Q. -- Black & Gold Resources, LLC, Charles C.
- 6 Albright III, Trustee, and Lillian and Kenneth
- 7 Rutherford, Trustees of the Rutherford Family Trust,
- 8 right?
- 9 A. That's correct.
- 10 Q. Okay. Did you locate all those people or were
- 11 some -- you talked about publication. Are there some of
- 12 them that only get notice by publication?
- 13 A. Yeah. We couldn't locate Landis Drilling or
- 14 Charles C. Albright III, Trustee.
- 15 Q. Okay. So they were included in the publication
- 16 that didn't happen -- didn't happen in time?
- 17 MR. BRUCE: They were included. Yeah.
- 18 EXAMINER BROOKS: And they will be
- 19 included.
- 20 MR. BRUCE: I will submit that at the next
- 21 hearing.
- 22 EXAMINER BROOKS: I think that's all.
- 23 CROSS-EXAMINATION
- 24 BY EXAMINER JONES:
- 25 Q. Are these parties working interest owners, all

- 1 of them?
- 2 A. Yes. They're all federal leases.
- 3 CONTINUED CROSS-EXAMINATION
- 4 BY EXAMINER BROOKS:
- 5 Q. I'm sorry. I forgot to ask about diligence to
- 6 locate. You probably already testified to that. Tell
- 7 us again.
- 8 A. Yeah. So we used the internal company records,
- 9 just searched our -- like, Mewbourne records. I used
- 10 LexisNexis to try to locate them, county records, just
- 11 general Googled their names, white pages, just anything
- 12 we could to find them.
- 13 **Q.** Okay.
- 14 CONTINUED CROSS-EXAMINATION
- 15 BY EXAMINER JONES:
- 16 Q. And these locations -- well locations --
- 17 nothing else has changed, because it's a federal well?
- 18 I just wondered if it changed from your last compulsory
- 19 pooling order, or -- I should just look it up in the OCD
- 20 records. Actually, there's nothing changed from before?
- 21 A. Correct.
- 22 Q. Thank you very much.
- 23 A. Yup.
- 24 EXAMINER JONES: Okay. We'll continue this
- 25 case, 15602, until May the 3rd.
