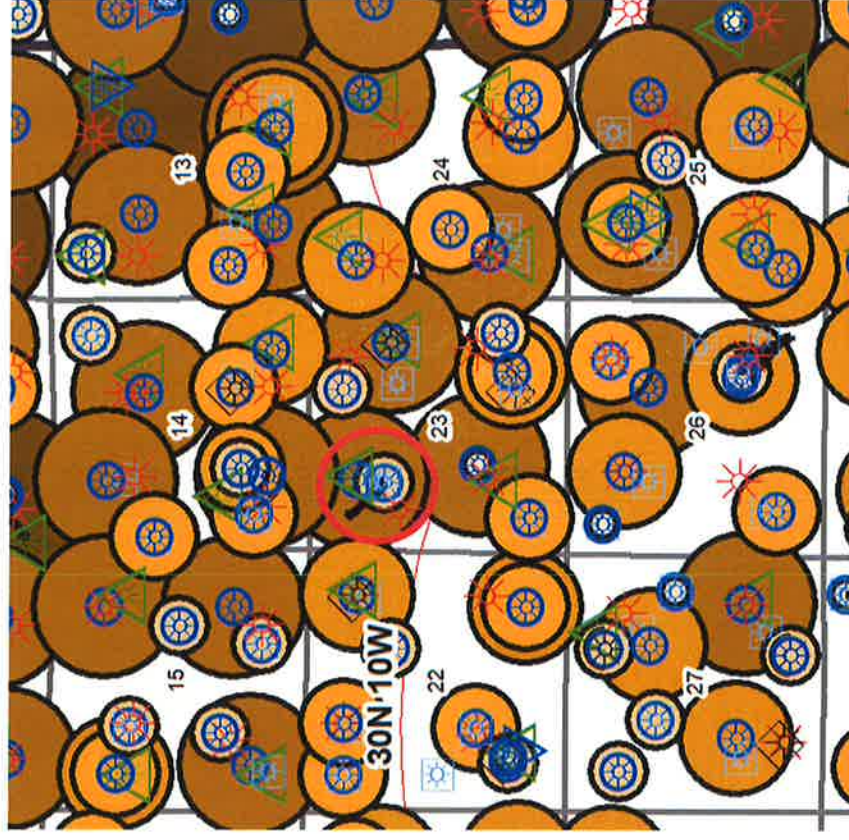

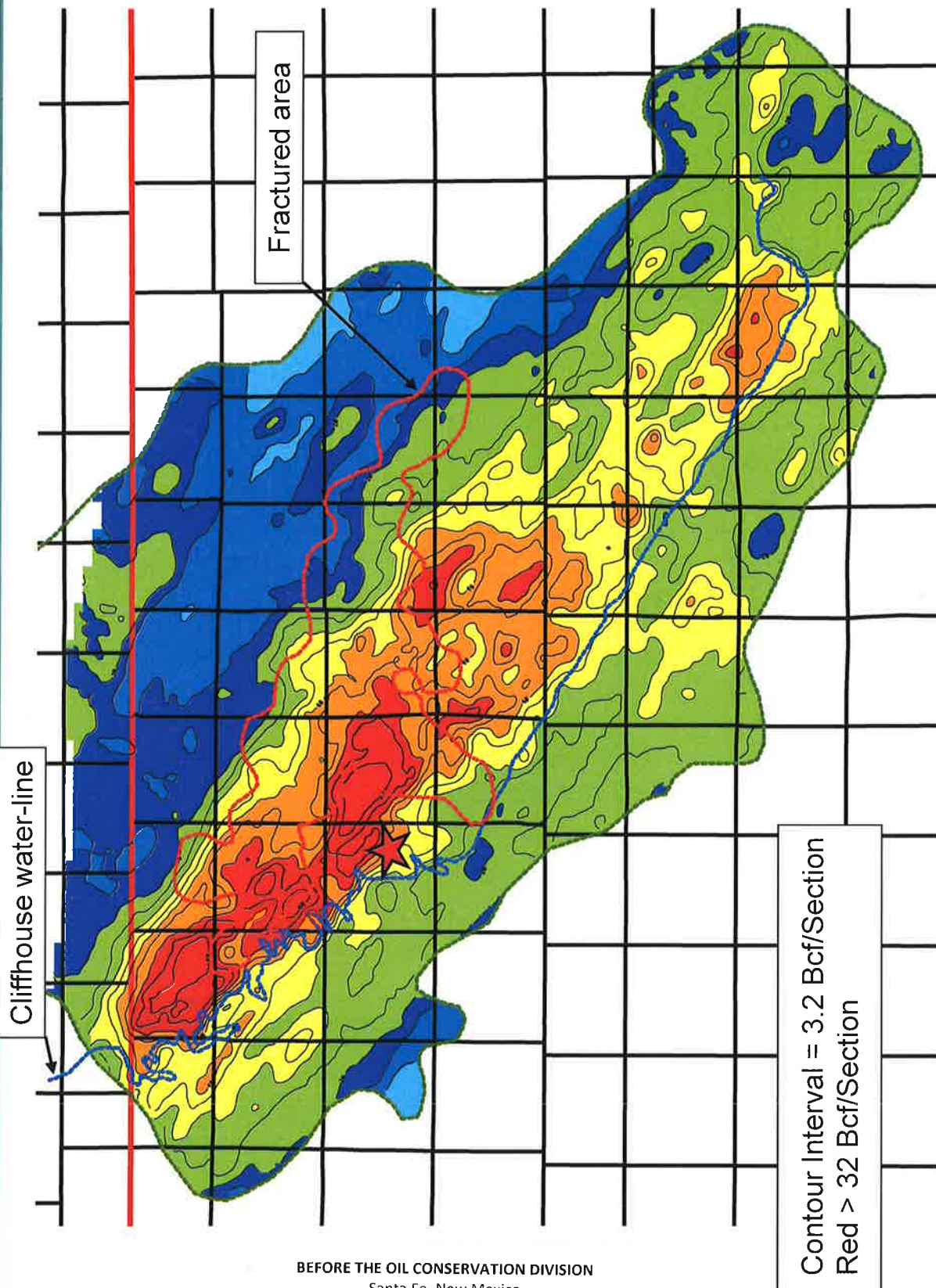

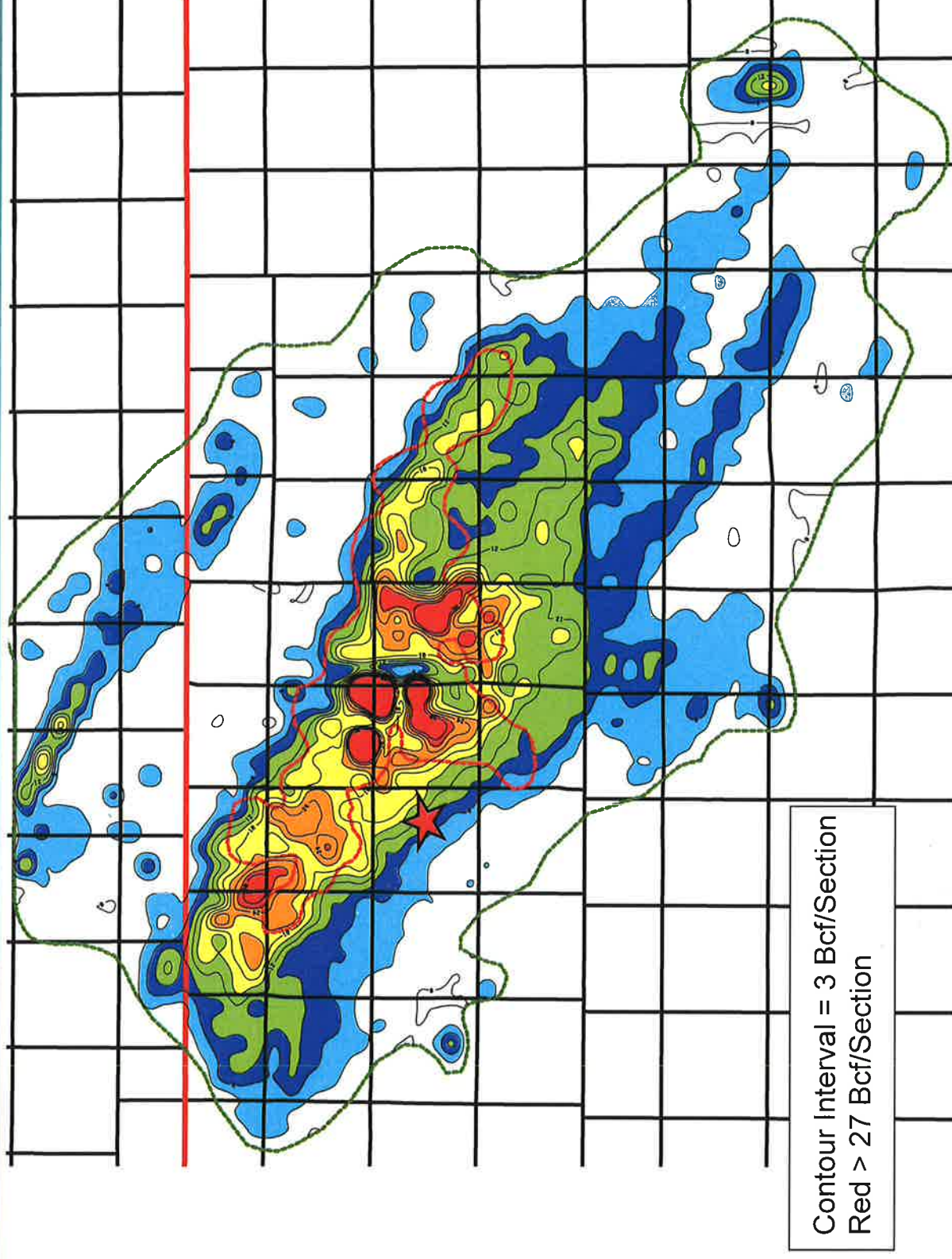
# MV Original Gas-in-Place



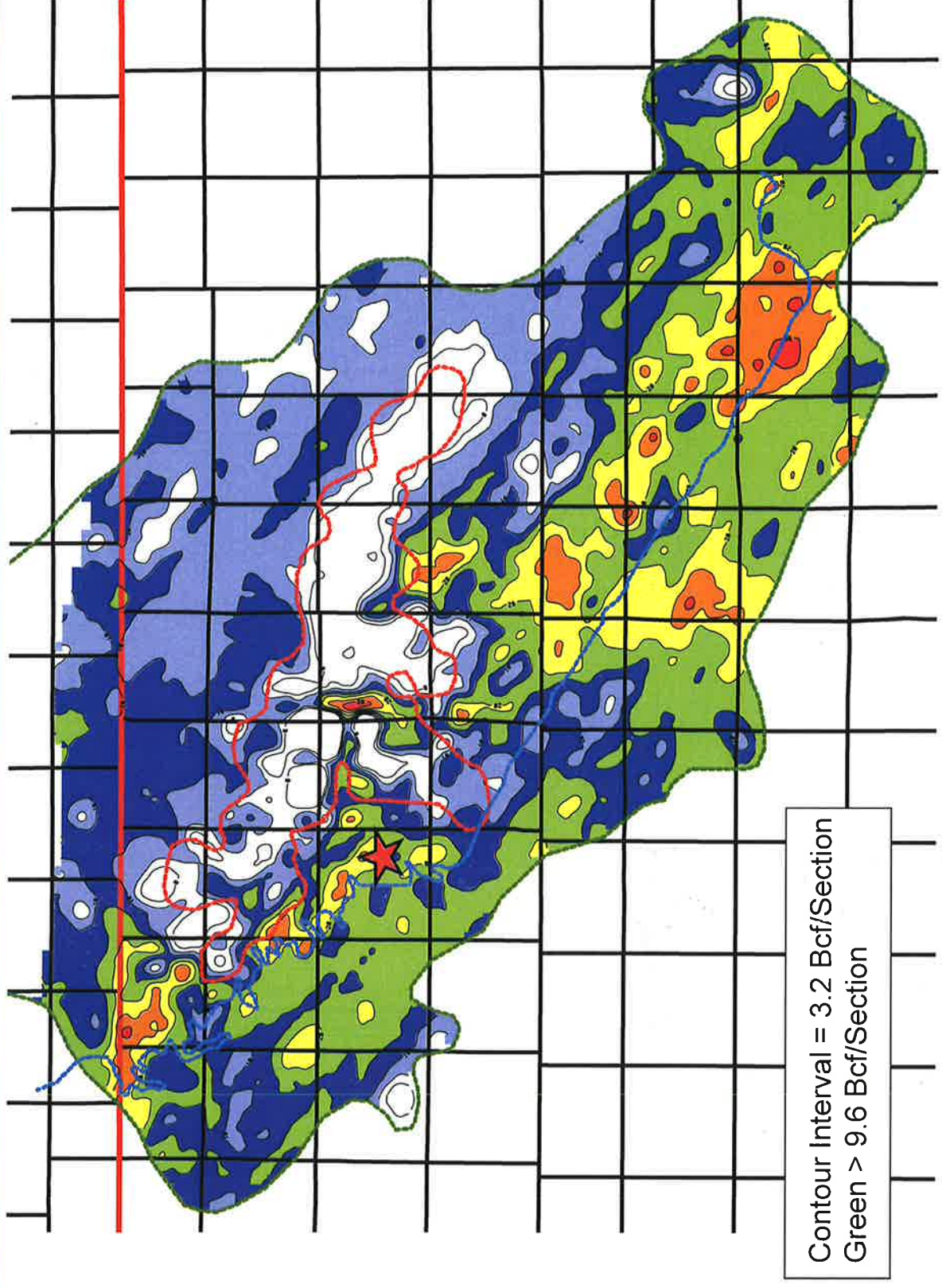
