3 to call this hearing back to order.

4 I need to do one housekeeping thing. I
5 believe it's Case 16130. I believe those are the two
6 SWD cases. There were some questions last night about
7 those two particular cases. Those cases shall be
8 continued until May the 31st, and after the hearing, I
9 need to speak to Adam about those cases.

10 This is what's going to happen today. The
11 first thing that's going to be occurring is that Adam
12 Rankin will be presenting notice cases, and then after
13 that, Scott Hall will be presenting cases.

14 With that in mind, the first case we're
15 going to hear today is Number 68 on the docket,
16 application of Chisholm Energy Operating, LLC for a
17 nonstandard spacing and proration unit and compulsory
18 pooling, Eddy County, New Mexico.

20 MR. RANKIN: Mr. Examiner, Adam Rankin on
21 behalf of the Applicant, Chisholm Energy. I have no
22 witnesses.

23 I have a supplemental exhibit. At the time
24 of the hearing, there were some parties who did not --
25 there were some parties that did not receive notice.

1 Publication was not timely published. In order to
2 perfect notice by publication, we reran the ad in the
3 "Carlsbad Current-Argus" identifying all notice parties
4 by name. That ad has run, and we received a notice of
5 the Affidavit of Publication. And I'd like to
6 supplement the record with that, with Exhibit Number 7,
7 If I might approach.

8 EXAMINER McMILLAN: Okay. Are there any

11 MR. RANKIN: Thank you, Mr. Examiner. This
12 is Exhibit Number 7, which is the notice of the
13 Affidavit of Publication reflecting that notice was
