- 3 hearing for Thursday, May 31st, 2018. I'm William V.
- 4 Jones.
- 5 This is David Brooks, Leonard Lowe and
- 6 Phillip Goetze.
- 7 And everybody knows we have restrooms
- 8 outside. We have Coke machines. We don't have any
- 9 coffee, but if you're -- if you find your attorney
- 10 dozing off, we have a defibrillator outside.

- Page 6, on the bottom, Case 16183 is
- 23 continued to June 14.
- 24 Page 7, Case 16184 is continued to June 14,
- and Case 16187 and 16188 is continued to June 14.

- 1 Page 8, all cases on that page are
- 2 continued to June 14. Those cases are 16189, 16190,
- 3 16191 and 16192.
- 4 On page 9, Case 16152 is continued to June

- MR. HALL: -- is continued to --
- MR. HERRMANN: June 14.
- MR. HALL: Voila.
- 22 EXAMINER JONES: On page 13, Case 16075 is
- 23 continued to June 14.
- Page 14, Case 16083 is continued to June
- 25 28th.

- 13 to that June 12th special hearing docket, which I
- 14 believe we've lined up a court reporter for that one.

- 17 On page 17, Case 16104 is also on the June
- 18 12th special hearing docket, continued to that date.
- 19 And Case 16131, Black River Water
- 20 Management, is dismissed. Case 16108 is continued to
- 21 June 28th. Case 16137 is continued to June 28th.
- 22 And on page 18, I have all those cases
- 23 continued to June 28th, which is the Kaiser-Francis
- 24 cases, Cases 16138, 16139, 16140, 16141.
- 25 On page 19, the first three Advance cases,

- 1 Cases 16092, 16093, 16094 are continued to June 14.
- 2 And on page 20, Case 16080 continued to
- 3 July the 26th, and Case 16061 continued to June 28th.
- 4 Case 16062 continued to June 28th.
- 5 The remaining OXY cases on pages 21 and
- 6 22 -- actually, those are Matador cases -- sorry -- are
- 7 continued to June 28th. I will read them in order:
- 8 Cases 16063, 16064, 16065, 16066, 16067 and, the last
- 9 one on page 22, 16068, all continued to June 28.
- 10 EXAMINER BROOKS: And the can has been
- 11 kicked.
- 12 EXAMINER JONES: Any other changes on the
- 13 docket?
- MR. FELDEWERT: Mr. Examiner, I'm Michael
- 15 Feldewert with Holland & Hart. If you look at page 7,
