STATEMENT OF THE CASE

Devon Energy Production Company ("Devon") seeks an order pooling all uncommitted mineral interests in the Bone Spring formation underlying Lots 1 – 4 of Section 30 and Lots 1 – 4 of Section 31 (W/2W/2 of Sections 30 and 31), Township 23 South, Range 29 East, Eddy County, New Mexico. Devon proposes to dedicate the above-referenced 312.39 acre spacing and proration unit as the standard horizontal spacing and proration unit for the **Spud Muffin 31-30 Fed Com 331H well** to be horizontally drilled in the **Cedar Canyon; Bone Spring (Pool Code 11520)** from a surface location 270' FSL and 1275' FWL of Section 31 to a bottom hole location of 230' FNL and 990' FWL of Section 30.

The well proposed to be drilled in this case will be pad-drilled sequentially and batch completed with other wells proposed in Case Nos. 16347, 16348 and 16349, and the completed intervals for all wells will be orthodox.
