2 EXAMINER McMILLAN: Good morning. Today is
3 June 14, 2018. This is Docket 26-18. My name is
4 Michael McMillan. I'll be the hearing examiner.

5 MS. BRADFUTE: Actually, all the Ender
6 Wiggins cases are going forward today.

7 MS. RYAN: Oh, they're going forward today?
8 Okay.

9 MS. BRADFUTE: But the other cases have all
10 been -- the Blueberry Hill and -- have been continued.

11 MS. RYAN: Okay. Thank you.

12 EXAMINER McMILLAN: So we're all set?

13 MS. BRADFUTE: Yeah.
