Dear Sir or Madam:

The following pertains to your request received by the Division on September 26, 2018 and to the requirements in the captioned hearing order.

You have requested an extension of the 120-day time limit given by the Division in the captioned order in which to drill and complete at least one of the captioned well(s) after commencement of drilling operations on the first of the proposed well(s).

As stated in your request, the operator has commenced drilling this well on June 7, 2018, but intends to simultaneously complete this well with a companion well [subject of a separate hearing order] by the second week in October 2018. Accordingly, you are requesting a 240-day time limit to replace the existing time limit.

The operator is hereby given 240 days as a time limit between the spud date of the first of the referenced proposed wells to the date the C-104 is approved for at least one of the proposed wells. All other provisions of this order remain in full force and effect.

Dear Ms. Riley:

Order Nos. R-14657 and R-14676 created 240-acre non-standard spacing and proration units and authorized compulsory pooling of uncommitted interest owners to the subject units. The Orders named Chisholm Energy Operating, LLC ("Chisholm") operator of the spacing units and the dedicated initial wells: the Outland 14-23 State 2BS 2H Unit Well and the Outland 14-23 State 2BS 3H Unit Well, respectively.

Paragraph 7 in both Orders requires that the proposed wells be drilled and completed within 120 days after commencement, or that an extension be obtained from the Division Director. Chisholm spudded the Outland 14-23 State 2BS 2H Unit Well on June 7, 2018, and is currently drilling the lateral portion of the Outland 14-23 State 2BS 3H Unit Well. It plans to complete both wells simultaneously and to move a crew to complete both wells by the second week of October 2018. However, because Chisholm pad drilled these wells and intends to simultaneously complete them, Chisholm will require additional time to comply with the 120-day deadline in Order R-14675. It also drilled a pilot hole to collect data and encountered some mechanical complications during drilling, all of which extended the time necessary for Chisholm to complete these wells.
