- 2 EXAMINER McMILLAN: Call Case Number 16393,
- 3 application of Southbound Gas Company for approval of a
- 4 saltwater disposal well, Roosevelt County, New Mexico.
- 5 Also at this hearing, Phil Goetze will be asking most of
- 6 the questions.
- 7 I'd like to call for appearances.
- MR. BRUCE: Mr. Examiner, Jim Bruce of
- 9 Santa Fe representing the Applicant.
- 10 EXAMINER McMILLAN: Are there any other
- 11 appearances?
- 12 Please proceed.
- MR. BRUCE: Mr. Examiner, this is for an
- 14 application for the Howell SWD well #1 located in
- 15 Section 23 of Township 2 South, Range 29 East. They're
- 16 seeking to inject water into the Pennsylvania Formation.
- 17 This is an existing well. And injection ceased for more
- 18 than two years, and so they had to get injection
- 19 authority reinstated. They applied administratively,
- 20 gave proper notice, and the only -- the one person
- 21 objected, which is Woody Investments, LLC, which is the
- 22 surface owner, and this application was filed. I gave
- 23 notice to Woody. The objection was filed by his
- 24 attorney -- by its attorney, Patrick McMahon, of the
- 25 Heidel, Samberson firm in Lovington. I filed this

- 1 application and gave notice. I asked Mr. McMahon to
- 2 give me a call. He never responded. Actual notice was
- 3 given to the party. They have not shown up.
- And I would ask that the matter be placed
- 5 back on the administrative docket subject to whatever
- 6 Mr. Goetze may desire.
- 7 EXAMINER GOETZE: On that note, so no phone
- 8 calls from Mr. McMahon or anybody in this firm with
- 9 regards to this?
- 10 MR. BRUCE: The surface owner and my client
- 11 and Mr. McMahon have spoken. It's all about surface
- 12 damages. That's why they objected. And it's fee
- 13 surface. It's all fee surface, so it's covered by the
- 14 Surface Owners Protection Act, which I doubt that the
- 15 Division wants to get involved in that. But that's
- 16 all --
- 17 EXAMINER GOETZE: Well, we have some
- 18 discussions about how much an SWD permit gives you
- 19 authority.
- 20 MR. BRUCE: Oh, yeah. I understand that.
- 21 I'm just saying that since it's fee surface, I'd like to
- 22 work this out among themselves.
- 23 EXAMINER GOETZE: Yeah, I understand.
- So there has been no change in any of the
- 25 other information provided in the C-108 that you're

- 1 aware of?
- 2 MR. BRUCE: I am not aware of any. I will
- 3 double-check with the client, and I will email you. But
- 4 I was told when I filed the application, there was no
- 5 change.
- 6 EXAMINER GOETZE: So we have taken a look
- 7 at it, and at this point, the application which you have
- 8 provided is satisfactory, and we will take it back into
- 9 administrative. And we'll go ahead and dismiss this
- 10 case with the understanding that the application will go
- 11 through the administrative review process.
- MR. BRUCE: Thank you.
- 13 EXAMINER McMILLAN: Okay. So Case Number
- 14 16393 shall be dismissed at this time.
- 15 EXAMINER GOETZE: Oh, wait a minute.
- 16 EXAMINER McMILLAN: Case Number 16393 shall
- 17 be re-opened. I need to --
- 18 Exhibit 1 with Attachment A may now be --
- 19 MR. BRUCE: I would ask that it be admitted
- 20 into the record.
- 21 EXAMINER McMILLAN: -- now be accepted as
- 22 part of the record.
- And, therefore, Case Number 16393 shall be
- 24 dismissed.
