
**UNOPPOSED MOTION TO STAY APPROVAL OF ORDER**

The New Mexico State Land Office (“NMSLO”), by and through its counsel, Andrea Antillon, hereby moves the Oil Conservation Commission (“OCC”) to stay the approval of the Order Amending the Well Density and Location Requirements and Administrative Exceptions of the Special Rules for thirty (30) days. In support of this motion, the NMSLO states:

1. Commissioners Balch and Dunn approved the NMSLO’s oral motion to stay the order for 30 days at the OCC hearing on December 4, 2018.
2. The 30 day stay will not harm Applicant, Hilcorp Energy Company and will allow for the administrative appeals process to run its course.
3. A stay is allowed and warranted under 19.15.4.23(B) NMAC.

WHEREFORE the NMSLO respectfully moves the OCC to enter an order staying the approval of the Order Amending the Well Density and Location Requirements and Administrative Exceptions of the Special Rules.


