8 actually presented in September, and it was presented by
9 affidavit. And notice -- there was an issue in this
10 case. Devon Energy -- somewhere along the intersection
11 of approximately the time the application was filed,
12 Devon Energy assigned its interest to Caza Petroleum,
13 and the Division -- Caza and Devon spent some time
14 negotiating, but the Division asked that we give
15 additional notice. So that's number one.

16 And then Mr. McMillan requested a C-102.
17 And notice was previously presented, but there was no
18 notice to Caza Petroleum.

19 So Exhibit A is the Affidavit of Notice to
20 Caza, which received actual notice, and then Exhibit B
21 is simply the C-102 for the well with the pool name and
22 pool code, which Mr. McMillan had requested.

23 EXAMINER JONES: Okay. So this is Mike's
24 case?

25 MR. BRUCE: Right.

1 So I'd move the admission of Exhibits A and
2 B and ask that the case be taken under advisement.

3 EXAMINER JONES: Exhibits A and B are
4 admitted, and Case 16392 is taken under advisement.
