2 EXAMINER JONES: Let's call Case 20120.  
3 Call for appearances.

4 MS. BROGGI: Mr. Examiner, Julia Broggi,  
5 with the Holland & Hart Law Firm, on behalf of the  
6 Applicant, COG Operating, LLC.

7 EXAMINER JONES: Other appearances?

8 MR. BRUCE: Mr. Examiner, Jim Bruce  
9 representing ConocoPhillips Company, and I have no  
10 objection to doing it by affidavit.

11 EXAMINER JONES: Any other appearances?

12 MS. BROGGI: This is the application of COG  
13 Operating, LLC for compulsory pooling in Lea County, New  
14 Mexico. This is the Goose State Com #601H well.

15 Again, the affidavit of the landman is  
16 Exhibit A. It's Danny Kidwell. COG is seeking to pool  
17 all the uncommitted interests in the Bone Spring  
18 Formation for this 160-acre horizontal spacing unit and  
19 to dedicate that horizontal spacing unit to the proposed  
20 Goose State well.

21 This is the case where COG is seeking to  
22 pool the one working owner, and it's ConocoPhillips  
23 Company. There are no unleased mineral interest owners,  
24 and COG is not seeking to pool overrides.

25 Exhibit B is the affidavit of the geologist

1 with the accompanying exhibits and his testimony that  
2 the granting of this application would be in the best  
3 interest of conservation, the prevention of waste and  
4 the protection of correlative rights.

5 Exhibit C is my affidavit regarding notice,  
6 but we're asking to continue this case to the January  
7 24th docket as well.

8 EXAMINER JONES: If that is all in this  
9 case, any objection to admitting these --

10 MR. BRUCE: No.

11 EXAMINER JONES: -- exhibits?

22 believe. Yeah, 100 percent of Tract 2.

23 EXAMINER JONES: Is there a chance they  
24 will sign the JOA?

25 MR. BRUCE: You got me. That's the best I
