2 EXAMINER McMILLAN: I'd like to call Case  
3 20050.

4 MR. BRUCE: Mr. Examiner, Jim Bruce of  
5 Santa Fe representing the Applicant. I ask that this be  
6 combined with Case 20051.

7 EXAMINER McMILLAN: Okay. 20050 and 20051  
8 shall be combined.

9 MR. BRUCE: Mr. Examiner, these cases  
10 involve Bone Spring and Wolfcamp wells in the west  
11 half-southwest quarter of 31 of 25-33 and the west  
12 half-west half Section 6 of 26-33. These cases were  
13 presented a couple of weeks ago. There was one -- one  
14 envelope -- one mailing that came back, and that was to  
15 Royalty Clearinghouse. But we got a new address, and I  
16 remailed notice to Royalty Clearinghouse and got the  
17 green card back. So submitted as Exhibit 6 is my notice  
18 letter to Royalty Clearinghouse showing that they did  
19 receive actual notice. So all the parties in this case  
20 received actual notice.

21 And I move the admission of Exhibit 6 and  
22 ask that the cases be taken under advisement.

23 (Kaiser-Francis Oil Company Exhibit Number  
24 6 is offered into evidence.)

25 EXAMINER McMILLAN: Well, looking at this,

1     there is no -- there's no date.

2                     MR. BRUCE:   No --

3                     EXAMINER McMILLAN:   I don't see a date on  
4     this (indicating).

5                     MR. BRUCE:   Well, Mr. Examiner --

6                     EXAMINER McMILLAN:   You see what I'm  
7     talking about?

8                     MR. BRUCE:   I see what you're saying, but  
9     I'm not in charge of that.   This is --

10                    EXAMINER McMILLAN:   Well, then, get --

11                    MR. BRUCE:   I will get you a date, I hope,  
12     off the post office website, but that site is almost  
13     useless anymore.   I know they're supposed to assign a  
14     date, but --

15                    EXAMINER McMILLAN:   I know.   But you  
16     understand our problem?

17                    MR. BRUCE:   Yeah.   But I will get that to  
18     you.

19                    EXAMINER McMILLAN:   Okay.

20                    EXAMINER BROOKS:   Well, you're saying that  
21     the recipient did not date the return receipt.

22                    EXAMINER McMILLAN:   We have no idea of the  
23     date.   That's what scares me about this.

24                    EXAMINER BROOKS:   Yes.   But our rule of  
25     return receipts says evidence of delivery "will be

1 provided if available."

2 MR. BRUCE: And I will check.

3 EXAMINER McMILLAN: Okay. That's fine.

4 EXAMINER BROOKS: If it's not available, we  
5 can take it under advisement because it says --

6 MR. BRUCE: I will check that this  
7 afternoon.

8 EXAMINER McMILLAN: Okay. Then Cases 20050  
9 and 20051 shall be taken under advisement under the  
10 contingency you'll attempt to find that information out.
