2 EXAMINER DAWSON: Moving on down the list,
3 we'll go to 16415, again Marathon Oil Permian, LLC for
4 compulsory pooling. It's for the Fremem 7 WD Fed Com
5 #1H Wolfcamp well.

6 MS. BENNETT: Good morning. Deana Bennett
7 for Marathon Oil Permian, LLC.

8 Again, this case was consolidated with Case
9 Number 16416, which is number 13 on page 1 of 5, and
10 this case was continued for notice purposes only. These
11 two cases were continued for notice purposes only.

12 EXAMINER DAWSON: Okay.

13 MS. BENNETT: And what I'm passing out now
14 is an affidavit prepared by myself that I've labeled as
15 Exhibit 19 to include with our previously submitted
16 materials.

17 EXAMINER DAWSON: Okay. And this is also
18 consolidated with docket number 11, Case 16417?

19 MS. BENNETT: That's accurate. There are
20 three cases altogether.

21 Thank you.

22 EXAMINER DAWSON: 16415, 16416 and 16417.

23 MS. BENNETT: Thank you.

24 As I mentioned, the exhibit that you have
25 before you today is an affidavit that I prepared, and

1 the affidavit contains the names and addresses provided
2 to us by Marathon Oil Permian and that we used to then
3 send our notice letters.

4 The next section shows a blue header, and
5 that blue-header paper, like the exhibit that I
6 mentioned, identifies the recipient and whether the
7 letter was received or not. This is our equivalent of
8 the green cards. We did multiple mailings in this
9 particular case to ensure that the overriding royalty
10 interest owners had notice of the hearing. So that's
11 why this one was continued and why there are two
12 different mailings.

13 And then at the end of my affidavit, you'll
14 see a notice of publication, an Affidavit of
15 Publication, from the "Carlsbad Current-Argus"
16 demonstrating that publication was effectuated for these
17 cases for the hearing today.

18 EXAMINER DAWSON: Okay. Any questions,
19 Mr. Brooks?

20 EXAMINER BROOKS: No questions.

21 EXAMINER DAWSON: Mr. Warnell?

22 EXAMINER WARNELL: No questions.
