1 HEARING EXAMINER: We will call Case Number 20281

- 2 and Case Number 20282. Call for appearance.
- 3 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe
- 4 representing the applicant, and I am submitting the case by
- 5 affidavit -- the cases.
- 6 I will start out with the land testimony on Case
- 7 20281.
- 8 MR. JONES: John Brown is still working?
- 9 MR. BRUCE: Yeah, he is.
- 10 In Case 20281, the affidavit of John Brown, the
- 11 landman in this case, Caza seeks forced pooling of the Bone
- 12 Spring Formation underlying the W/2 W/2 of Section 34, 22
- 13 South, 35 East, Lennox 34, State Well Number 1H. There are
- 14 no depth severances in the Bone Spring Formation.
- 15 C-102 for the well is attached. It is a
- 16 permitted well. It's in the Rock Lake Bone Spring Pool, and
- 17 the API number is given.
- 18 Exhibit B shows the parties being pooled.
- 19 Exhibit -- Attachment C is the proposal letter to
- 20 the parties. And Attachment C on the second page also shows
- 21 the interests, the working interests of various parties.
- 22 Other than Caza, those five companies, Caza seeks to force
- 23 pool Gaedeke Holdings, Allar Company, Strategic Energy,
- 24 Highlands Energy and Chevron USA.
- 25 Exhibit D is an AFE for the well. The AFE is a

- 1 little over \$8 million, which is stated to be fair and
- 2 reasonable in these circumstances. Caza is requesting
- 3 750 -- \$7500 a month for a drilling well, 750 a month for a
- 4 producing well. It also requests that its operating, Caza
- 5 Operating LLC, be designated operator of the well.
- 6 Exhibit 2 is my affidavit of notice. There is
- 7 one green card that didn't come back, Strategic Energy
- 8 Income Fund. We did publish notice as against all of the
- 9 parties, and that's -- maybe Mr. Brooks can opine here.
- 10 What I have submitted to you is the -- the advertising
- 11 invoice with the legal notice attached.
- 12 It was published in the Hobbs Newspaper. I never
- 13 got the affidavit of publication from the Hobbs Newspaper.
- 14 I e-mailed them, and they are supposed to e-mail me back the
- 15 various affidavits of publication. There are seven of them
- 16 that I didn't get. I haven't received that yet.
- 17 If, if -- since it's only an affidavit of
- 18 publication, I would -- if it needs to be continued, I
- 19 would ask to put it on the March 21 docket. I know there is
- 20 a ton of cases, but it's just an affidavit of publication.
- 21 Otherwise, I'm sure I will get them and I can supplement the
- 22 record with them.
- 23 MR. BROOKS: I think I will have to check the
- 24 rule on service by publication to see if the affidavit of
- 25 publication is actually required or not. I do not believe

- 1 it is, but I wouldn't want to opine incorrectly.
- 2 MR. BRUCE: That's Mr. Carr's job.
- 3 MR. BROOKS: Although I have done that a few
- 4 times in my life.
- 5 MR. CARR: He doesn't recognize the truth.
- 6 MR. BRUCE: But it was, again, once again, it was
- 7 Strategic Energy Income Fund I did not get a green card
- 8 back, but I don't mind continuing it it for two weeks, but I
- 9 don't want to continue it for six weeks merely to submit a
- 10 one-page affidavit of publication.
- 11 MR. BROOKS: That makes sense. I don't think
- 12 it's necessary to continue it at all, but I want to just
- 13 check.
- MR. JONES: Has it been the practice to -- was a
- 15 newspaper notice required?
- 16 MR. BROOKS: That's the question I have. I am
- 17 now looking to find the rule.
- 18 MR. JONES: Because you didn't get a green card
- 19 back; right?
- 20 MR. BROOKS: A green card is not required.
- 21 MR. JONES: I can make a petition to our docket
- 22 manager to try to get him to -- I can say, well --
- MR. BRUCE: Just submit.
- 24 MR. BROOKS: The rule on proof of receipt is, I
- 25 recall that because I remember being very surprised when I

1 looked it up, it says that proof of receipt shall be filed

- 2 if available. That's kind of a non-rule.
- Well, since it will never come up in any context
- 4 in all probability, and I can't find it quickly, I'm going
- 5 to say let's go ahead and take it under advisement.
- 6 MR. BRUCE: I will supplement the record with
- 7 that whenever I get it.
- 8 MR. BROOKS: Okay. We appreciate it.
- 9 MR. JONES: That way you don't have to wrestle
- 10 Terri.
- 11 MR. BROOKS: You don't want to wrestle Terri. I
- 12 will wrestle Terri.
- MR. JONES: Or Gabe.
- MR. BROOKS: Now, you really don't want to have
- 15 to wrestle Gabe.
- 16 MR. BRUCE: And next I'll give you the land
- 17 exhibits for Case 20282. And 20282 --
- 18 HEARING EXAMINER: We will call Case Number
- 19 20282. Call for appearance.
- 20 MR. BRUCE: Jim Bruce of Santa Fe representing
- 21 the applicant.
- MR. BRUCE: The materials I just handed you are
- 23 virtually identical to what I just handed you for Case
- 24 20281.
- The well unit for this well, the 1X34C, well

1 number, it says 1H and 2H in Paragraph 2C is the E/2 W/2 of

- 2 34. The prior one was the W/2 W/2.
- 3 There are different interest owners -- not
- 4 different -- there are additional interest owners in this
- 5 well, so -- and if you go through the affidavit, which is
- 6 virtually the same, you will see Attachment C which is a
- 7 proposal letter contains a list of the interest owners, and
- 8 all of the interest owners, other than Caza, are being
- 9 pooled, and it gives the percentage interests.
- 10 Exhibit 2 is my affidavit of notice, and in this
- 11 case two people, Strategic Energy Income Fund and Randall
- 12 Harris, I have no green cards back from them.
- 13 Exhibit 3, again, is a copy of the notice
- 14 published in the Hobbs Newspaper for -- again, for which I
- 15 did not receive an affidavit of publication.
- 16 MR. JONES: Was it -- do you think it was
- 17 published?
- 18 MR. BRUCE: It was published, yeah.
- 19 MR. JONES: Within ten days before this hearing?
- 20 MR. BRUCE: I know it was published because
- 21 they -- they -- you submit it, you submit the notice, and
- 22 then they ship it back to you and ask you if what you see
- 23 here looks good. And they say, "We'll publish it on
- 24 such-and-such a date." And -- and I have always gotten the
- 25 affidavits of notice, so I don't know what happened.

I guess there was seven of them outstanding as of

- 2 this morning, and I was looking for them when I went back to
- 3 my office this morning, but it wasn't happening.
- 4 MR. JONES: Is Randall Harris, is he okay? He
- 5 still --
- 6 MR. BRUCE: He is still -- as far as I know.
- 7 MR. JONES: He was the geologist for Ray Westall
- 8 for a long time and then switched over to Endurance.
- 9 MR. BRUCE: I believe Endurance sold out, but,
- 10 yeah, he is still around.
- MR. JONES: But so is Ray Westall, but they are
- 12 not retiring their green cards.
- MR. BRUCE: Well, Ray Westall did.
- 14 And then, finally, there is an affidavit of
- 15 Richard Carroll. That was together with the materials I
- 16 sent you for 20281, and it contains information on the
- 17 wells. They are both in the First Bone Spring test, and
- 18 there is a locator map, a structure map showing dipping
- 19 slightly to the east, an isopach map, and there are two
- 20 cross-sections, a structural cross-section and stratigraphic
- 21 cross-section which also showing the target zone which is in
- 22 the upper part of the First Bone Spring.
- 23 And then well water, horizontal well water plans
- 24 are also attached. And it contains the usual information.
- 25 The horizontal units are justified from a geologic

1 standpoint. The Bone Spring is continuous across and each

- 2 quarter-quarter section in the unit will contribute
- 3 more-or-less equally in production.
- 4 So with that I would move the admission of
- 5 Exhibits 1 through 3 in case 20281, Exhibits 1 through 3 in
- 6 Case 20282, and then because the geology was identical, I
- 7 just made one single geologic exhibit, Exhibit 4, for both
- 8 case. And with that I would move the admission of those
- 9 exhibits and ask that the case -- cases be taken under
- 10 advisement.
- 11 HEARING EXAMINER: All your exhibits are
- 12 admitted, and Case Number 20282 will be taken under
- 13 advisement.
- So at this time we will take our lunch break, and
- 15 we shall reconvene at 1:30.
