In Case No. 20220, Marathon seeks an order from the Division pooling all uncommitted mineral interests in a Wolfcamp spacing unit underlying the E/2 of Section 15, Township 24 South, Range 34 East, NMPM, Lea County, New Mexico. This spacing unit will be dedicated to the Will Kane 15 WXY Fee 3H, Will Kane 15 WB Fee 4H, Will Kane 15 WA Fee 6H, Will Kane 14 WXY Fee 10H, and Will Kane 15 WB Fee 11H wells, to be horizontally drilled. The producing area for these wells will be orthodox. Also to be considered will be the cost of drilling and completing said wells, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of Marathon as operator of the wells, and a 200% charge for risk involved in drilling said wells, and allowing a one year period between when the wells are drilled and when the wells are completed. Said area is located approximately seventeen (17) miles west of Jal, New Mexico.

Also to be considered will be the cost of drilling and completing said well, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of Marathon as operator of the well, and a 200% charge for risk involved in drilling said well, and allowing a one year period between when the well is drilled and when the well is completed.
