## STATEMENT OF CASE

### **APPLICANT:**

In Case No. 20150, NGL seeks an order approving disposal into the Silurian-Devonian formation through the Maverick SWD #1 well at a surface location 1086 feet from the South line and 151 feet from the East line of Section 29, Township 24 South, Range 34 East, NMPM, Lea County, New Mexico for the purpose of operating a salt water disposal well. NGL seeks authority to inject salt water into the Silurian-Devonian formation at a depth of 16,615' to 18,265'. NGL further seeks approval of the use of 7 inch tubing inside the surface and intermediate casings and 5 ½ inch tubing inside the liner and requests that the Division approve a maximum daily injection rate for the well of 50,000 bbls per day. Said area is located approximately 18 miles northwest of Jal, NM.
