In Case No. 20463, Blackbuck seeks an order for a salt water disposal well in its **Olive Branch SWD Fed 1**, to be drilled at a location 979 FSL and 2,620 FEL, Unit N, Section 17, Township 24 South, Range 3 East, N.M.P.M., Lea County, New Mexico for injection into the Devonian-Silurian formations at depths between 16,825' through 18,290' open hole. The well will be located approximately 22 miles east of Malaga, New Mexico.
