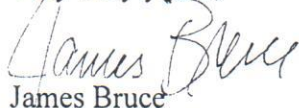
Ladies and gentlemen:

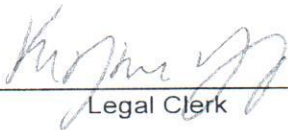

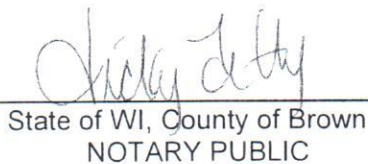

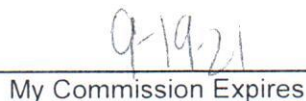

The unit will be dedicated to the Pavo Frio 29/28 B2J1 Fed. Com. Well No. 1H, with a first take point in the NW/4SE/4 of Section 29 and a final take point in the NE/4SE/4 of Section 28. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
