APPLICANT'S STATEMENT OF THE CASE

In Case No. 20575, NGL seeks an order approving disposal into the Silurian-Devonian formation through the Ghost Rider SWD #1 well. NGL proposes to drill this well at a surface location 1,585 feet from the South line and 270 feet from the East line of Section 30, Township 26 South, Range 35 East, NMPM, Lea County, New Mexico. The target injection interval is the Silurian-Devonian formation at a depth of 18,953' – 20,729'. NGL further seeks approval of the use of 7 inch tubing inside the surface and immediate casings, and 5½ inch tubing inside the liner and requests that the Division approve a maximum daily injection rate for the well of 50,000 bbls per day.


