- 3 application of OXY USA, Incorporated for compulsory
- 4 pooling, Eddy County, New Mexico.
- 5 Call for appearances.
- 6 MS. LUCK: Kaitlyn Luck with the Santa Fe
- 7 office of Holland & Hart.
- 8 MR. BRUCE: Mr. Examiner, Jim Bruce
- 9 representing MRC Permian Company.
- 10 EXAMINER JONES: No other appearances?
- 11 Please proceed.
- MS. LUCK: Thank you.
- 13 EXAMINER BROOKS: This is 20528?
- 14 EXAMINER JONES: 550.
- 15 EXAMINER BROOKS: 550.
- MS. LUCK: In this case OXY seeks an order
- 17 pooling the uncommitted interests in the Wolfcamp
- 18 Formation underlying a standard 640-acre horizontal
- 19 spacing unit comprised of the east half of Sections 20
- 20 and 29, Township 24 South, Range 29 East, Eddy County,
- 21 New Mexico. In support of this application, OXY
- 22 presents the affidavit of the Jeremy Murphrey. He is a
- 23 petroleum landman whose credentials have been accepted
- 24 and made a matter of record. He's familiar with the
- 25 application filed by OXY and the status of these lands.

1 Exhibit Al is a plat showing these three

- 2 wells containing this application, the proposed initial
- 3 wells and the subject acreage that consists only of
- 4 federal and fee land.
- 5 Exhibit A2 is the C-102 for all three
- 6 wells, the Salt Flat CC 20-29 Fed Com 34H, 36H and 38H.
- 7 And while these C-102s are not yet approved, OXY has
- 8 been advised that these wells have been place in Purple
- 9 Sage; Wolfcamp Pool, pool code 98220. The completed
- 10 interval for these wells will comply with the special
- 11 rules for the Purple Sage; Wolfcamp Pool.
- 12 Exhibit A3 identifies the ownership in the
- 13 proposed spacing unit and the tracts of land. You'll
- 14 see that OXY seeks to pool only a few uncommitted
- 15 working interest owners who OXY has been able to locate.
- 16 OXY is continuing to negotiate with these parties and
- 17 will advise the Division if they are able to reach an
- 18 agreement with anyone. Those parties to be pooled are
- 19 highlighted in yellow on Exhibit A3.
- 20 Exhibit A4 are sample well-proposal
- 21 letters, along with the AFE that were sent to the
- 22 working interest owners to be pooled in these
- 23 proceedings. The cost reflected in the AFE are
- 24 consistent with what OXY and other operators have
- 25 incurred for drilling and completing similar horizontal

- 1 wells in the formation. And there are no depth
- 2 severances or unleased mineral interests in the subject
- 3 acreage. OXY has estimated overhead and administrative
- 4 costs of \$7,500 per month while drilling and 750 per
- 5 month while producing.
- 6 Behind Exhibit B OXY presents the testimony
- 7 of Tony Troutman. He's a geologist who -- he's a
- 8 geologist with OXY who has also been accepted as an
- 9 expert witness in petroleum geology. He has conducted a
- 10 study of the Wolfcamp Formation underlying this acreage.
- 11 These three wells intend to target the upper Wolfcamp
- 12 interval of the Wolfcamp Formation.
- His Exhibit B1 is a structure map showing
- 14 the three wells with contour lines every 25 feet, the
- 15 wellbore paths and injections at 20 and 29 on the map,
- 16 and he does not observe any faulting, pinch-outs or
- 17 geologic impediments to developing the targeted interval
- 18 with the horizontal wells.
- 19 Exhibit B2 are his -- the sets of wells he
- 20 used to construct the stratigraphic cross section, again
- 21 from A to A prime and B to B prime.
- 22 These wells are then shown on his OXY
- 23 Exhibit B3, which show the upper Wolfcamp target is
- 24 present throughout the proposed wellbore -- throughout
- 25 the target interval and continuous across the subject

- 1 acreage. He also opines that the north-to-south
- 2 orientation for the proposed wells is appropriate. In
- 3 his opinion, the granting of OXY's application will be
- 4 in the best interest of conservation and the prevention
- 5 of waste and the protection of correlative rights.
- 6 Behind Exhibit C, you'll find an affidavit
- 7 by me from my office showing that the notice letters and
- 8 the applications were provided to the interest owners
- 9 that OXY seeks to pool.
- 10 With that, OXY would ask -- I would move to
- 11 admit Exhibits A, B and C and then ask that the case be
- 12 taken under advisement.
- 13 EXAMINER JONES: Any objection, Mr. Bruce?
- MR. BRUCE: No objection.
- 15 EXAMINER JONES: Okay. The well -- the
- landman says it's going to be standard, but the well
- 17 location plat shows nonstandard. Can you just clarify
- 18 that discrepancy and just email me on that?
- 19 It shows 100-feet setbacks from the first
- 20 and last take points, Purple Sage, unless Mr. Brooks
- 21 would have changed the rules for the Purple Sage in the
- 22 Horizontal Well Rule, we would have that.
- 23 EXAMINER BROOKS: There was a lady here --
- 24 EXAMINER JONES: It's all his fault.
- 25 EXAMINER BROOKS: There was a lady here

that was here one afternoon who was vehemently opposed

to that.

MS. LUCK: Who was that?

4 EXAMINER BROOKS: Jennifer Bradfute.

5 MS. LUCK: Oh. You're blaming it on her?

6 EXAMINER JONES: He passes the buck.

7 EXAMINER BROOKS: The Horizontal Well Rule

8 Committee somewhat operated on the "who he makes the

9 loudest growl gets the most oil."

10 EXAMINER JONES: There is a lot of growling

11 since then about this Purple Sage.

Well, just sent me an email if you don't

13 mind.

MS. LUCK: I will do that, and I will get

15 back to you on this case.

16 EXAMINER JONES: And we'll go ahead and

17 admit Exhibits A, B and C with their attachments in Case

18 20550 and take the case taken under advisement.
