The unit will be dedicated to the Mosaic Fed. 2419 3BS Well No. 1H, with a first take point in the NW/4NW/4 of Section 24 and a final take point in the NE/4NE/4 of Section 19;

(b) all mineral interests in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2N/2 of Section 24, Township 23 South, Range 28 East, NMPM and the S/2N/2 of Section 19, Township 23 South, Range 29 East, NMPM. The unit will be dedicated to the Mosaic Fed. 2419 3BS Well No. 2H, with a first take point in the SW/4NW/4 of Section 24 and a final take point in the SE/4NE/4 of Section 19; and
