VERIFIED STATEMENT OF TYLER JOLLY

Tyler Jolly, being duly sworn upon his oath, deposes and states:

1. I am a landman for Mewbourne Oil Company ("Mewbourne"), and have personal knowledge of the matters stated herein. I have been qualified by the Division as an expert petroleum landman.

2. Pursuant to Division Rules, the following information is submitted in support of the compulsory pooling application:

(a) The purpose of this application is to force pool working interest owners into the horizontal spacing unit described below, and in wells to be drilled in the unit.

(b) No opposition is expected because the interest owner being pooled has been contacted regarding the proposed wells, but has simply failed or refused to voluntarily commit his interest to the wells.

(c) A plat outlining the unit being pooled is attached hereto as Attachment A. Mewbourne seeks an order pooling of all mineral interests in a horizontal spacing unit in the Wolfcamp formation (Purple Sage-Wolfcamp Gas Pool; Pool Code 98220) comprised of the NW/4 of Section 21 and the W/2 of Section 16, Township 24 South, Range 28 East, NMPM. The wells Mewbourne seeks to drill in the unit are:

(a) the Creedence 21/16 W1ED State Com. Well No. 1H;

(b) Creedence 21/16 W0ED State Com. Well No. 2H;

(c) the Creedence 21/16 W1FC Fed. Com. Well No. 3H; and

(d) the Creedence 21/16 W0FC State Com. Well No. 4H.

EXHIBIT |

Forms C-102 for the wells are contained in Attachments B-1 through B-4.

- (d) There is no depth severance in the Wolfcamp formation.
- (e) The party being pooled and his interest are set forth in Attachment C.
- (f) Attachment D is the well proposal letter sent to the pooled interest owner. His current and correct address is on the letter.
- (g) Mewbourne has made a good faith effort to obtain the voluntary joinder of the working interest owners in the proposed well.
- (h) Mewbourne has the right to pool the overriding royalty owners in the well unit.
- (i) Attachments E-1 through E-4 are the Authorizations for Expenditure for the proposed wells. The estimated cost of the wells set forth therein are fair and reasonable, and are comparable to the costs of other wells of similar depth and length drilled in this area of Eddy County.
- (j) Mewbourne requests overhead and administrative rates of \$8000/month for a drilling well and \$800/month for a producing well. These rates are fair, and comparable to the rates charged by other operators for wells of this type in this area of Eddy County. They are also the rates set forth in the Joint Operating Agreement for the well unit. Mewbourne requests that these rates be adjusted periodically as provided in the COPAS Accounting Procedure.
- (k) Mewbourne requests that the maximum cost plus 200% risk charge be assessed against non-consenting working interest owners.
- (l) Mewbourne requests that it be designated operator of the well.
- (m) The attachments to this affidavit were prepared by me or under my supervision, or compiled from company business records.
- (n) The granting of this application is in the interests of conservation and the prevention of waste.
