STATEMENT OF THE CASE

In Case No. 20473, Applicant Solaris Water Midstream, LLC (“Solaris”) seeks an order from the Division approving disposal of salt water in the Devonian formation at depths of 16,689 to 18,167 feet through the Jesse Spano State SWD well, located 295 feet FNL and 2505 feet FWL of Section 36, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico.

Tap Rock has acreage in the immediate vicinity of Solaris’s proposed well and is concerned about the potential for a drilling hazard and adverse impact on future production, which could result from injecting large volumes of liquid into a formation that will be drilled through in the future.
