APPLICANT'S STATEMENT OF CASE

Ameredev seeks an order (1) pooling all uncommitted interest in the Wolfcamp formation (Jal; Wolfcamp West (Pool Code 33813)), underlying a standard 467.40-acre, more or less, spacing unit comprised of the W/2 W/2 of Section 27, E/2 E/2 of Section 28, W/2 NW/4 of irregular Section 34, and the E/2 NE/4 of Section 33, Township 26 South, Range 36 East, N.M.P.M., Lea County, New Mexico, and (2) dedicating the above-referenced horizontal spacing unit to the proposed **Amen Corner State Com 26-36-27 121H Well** (API No. 30-025-44942), which will be

horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 22 to a bottom hole location in the SW/4 NW/4 (Lot 4) of irregular Section 34. The completed interval of the **Amen Corner State Com 26-36-27 121H Well** will remain within 330 feet of the section line separating: (1) the W/2 W/2 of Section 27 from the E/2 E/2 of Section 28, and (2) the W/2 NW/4 of irregular Section 34 from the E/2 NE/4 of Section 33, to allow inclusion of this acreage into a standard 467.40-acre horizontal well spacing unit.
