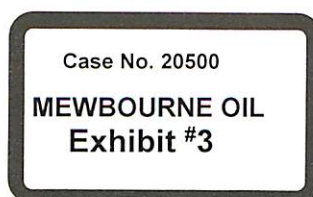
4. The well location identified on the C-102 matches the well location that I identified in my well proposal letters and the evidence presented at the June 11, 2019 hearing.
