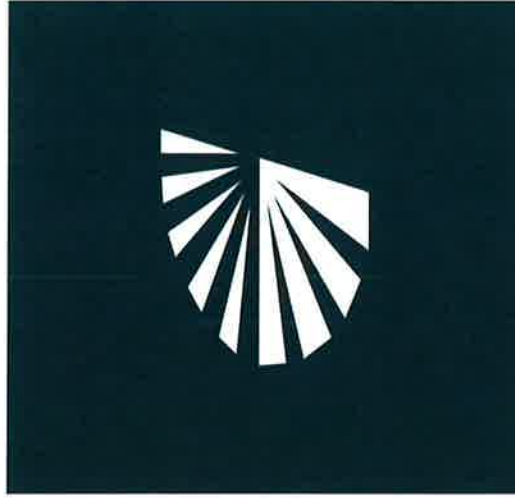


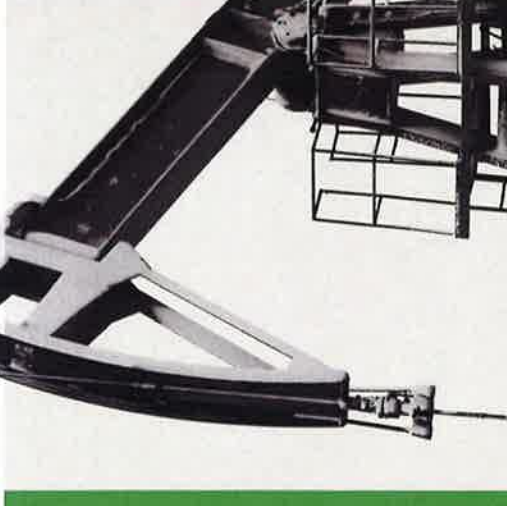

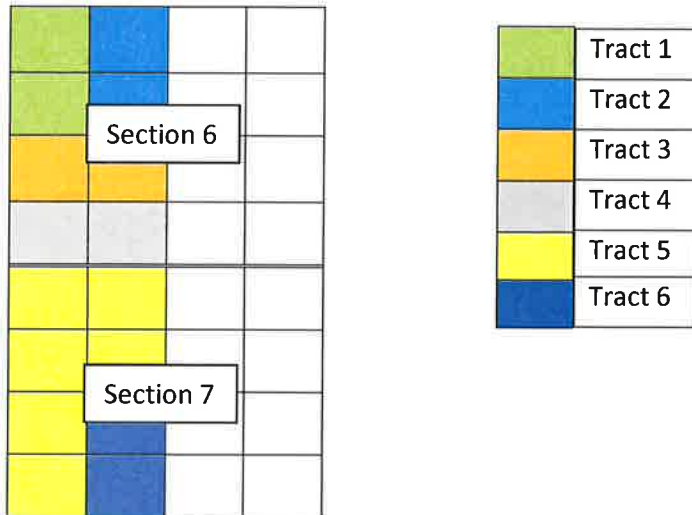

- The Stove Pipe Federal Com #705H well to be drilled from a surface hole location in SE/4 SW/4 (Unit N) of irregular Section 31, T24S, R35E, to a bottom hole location in the SW/4 SW/4 (Lot 4) of irregular Section 7, T25S, R35E.

The completed intervals for the proposed **Stove Pipe Federal Com #602H** well will be within 330' of the quarter-quarter line separating the W/2 W/2 equivalent and the E/2 W/2 equivalent of irregular Sections 6 and 7 to allow inclusion of this acreage into a standard 640-acre horizontal well spacing unit. Also, to be considered will be the cost of drilling and completing the wells, the allocation of the cost thereof, the actual operating costs and charges for supervision, the designation of applicant as operator, and the imposition of 200% charge for risk involved in drilling and completing each well. Said area is located approximately 12.5 miles southeast of Jal, New Mexico.
