#### **MARATHON'S STATEMENT OF CASE**

Marathon files this Pre-Hearing Statement out of an abundance of caution because Marathon has requested a continuance of these cases due to a scheduling conflict with Marathon's counsel, who has a required hearing in federal court in Montana on August 22, 2019, and so cannot be available for this hearing. As Marathon explained in its Motion for Continuance, Marathon is a working interest in the proposed unit yet Chisholm Energy Operating, LLC did not send Marathon a proposal letter nor did it seek to pool Marathon's working interest ownership. Marathon intends to appear at the hearing in these cases to present evidence of Marathon's working interest ownership. Marathon has requested a continuance through October 17, 2019 to give Marathon and Chisholm more time to engage in discussions and potentially resolve the issue as to Marathon's working interest.
