- 2 EXAMINER LOWE: Good morning. Today is
- 3 August 8th, 2019. My name is Leonard Lowe, and I'm your
- 4 hearing examiner today for Docket Number 28-19. Good
- 5 morning.
- I have with me a new attorney for the OCD,
- 7 Mr. Dana David. He'll be replacing Mr. David Brooks who
- 8 retired just recently. So he'll be helping -- assisting
- 9 me with our OCD hearings from now on.
- 10 EXAMINER DAVID: Well, just here in the
- 11 near term, until we hire a replacement for Mr. Brooks.
- 12 I'm just a temporary fill-in.
- 13 EXAMINER LOWE: Welcome, Mr. David.
- 14 EXAMINER DAVID: Thank you.
- 15 EXAMINER LOWE: And we have Michael
- 16 McMillan assisting me this morning. He will be helping
- 17 us today, helping me, maybe tomorrow. We shall see what
- 18 happens.
- 19 I'm going to read off the docket for today.
- 20 Let's see here. I don't know if we have all --
- 21 everybody has copies of the -- we're going back to the
- 22 old format of what the case docket is going to be going
- 23 by. So we have 16 pages.
- 24 Of the 16 pages, we had initially 59 cases
- 25 set for hearing. Of the 59, 36 will be heard today. Of

1 the 36, 20 are continued and three are dismissed, as I

- 2 was last made aware of. And I will go through that.
- 3 After I finish, I will announce additional information
- 4 pertaining to our docket.
- So on page 1, Case Number 20657,
- 6 application of Milestone Environmental Services, LLC for
- 7 approval of a saltwater disposal well, Lea County, New
- 8 Mexico is continued to August 22nd.
- 9 Case Number 20658 -- actually never mind.
- 10 Hold on -- will be heard today.
- Going to page 2 -- page 2, Case Number
- 12 20659, which is number six on the docket, will be
- 13 continued to August 22nd. Number seven, Case Number
- 14 20660, will be continued to September 9th.
- MS. SALVIDREZ: 19th.
- 16 EXAMINER LOWE: 19th. Sorry.
- Page 3, case number ten, Case Number 20663,
- 18 is dismissed. And then number 12, Case Number 20666, is
- 19 continued to August 22nd.
- 20 Page 4, Case Number 20667 is continued to
- 21 August 22nd. Number 14, Case Number 20668, is
- 22 dismissed.
- We'll skip page 5 and go to page 6.
- 24 Page 6, number 23, Case Number 20676, is
- continued to August 22nd. Number 24, Case Number 20677,

- 1 is continued to September 19th.
- Page 7, number 26, Case Number 20679, is
- 3 continued to August 22nd.
- Page 8, number 31, Case Number 20686, is
- 5 continued to September 19th. Number 33, Case Number
- 6 20688, is continued to September 19th.
- Page 9, number 35, Case Number 20690, is
- 8 continued to August 22nd.
- 9 Page 10, number 38, Case Number 20693, is
- 10 continued to September 19th.
- 11 Page 11 will be heard today.
- Page 12, number 44, Case Number 20699, will
- 13 be continued to September 19th.
- Number 45, Case Number 20700, is continued
- 15 to October 31st. Yay.
- 16 (Laughter.)
- 17 Page 13, number 47, Case Number 20702, is
- 18 dismissed. Number 49, Case Number 20704, is continued
- 19 to October 31st.
- 20 Page 14, number 50, Case Number 20705, is
- 21 continued to September 19th. 51, Case Number 20706, is
- 22 continued to October 31st.
- 23 Page 15, number 53, Case Number 20708, is
- 24 continued to September 19th. And number 55, Case Number
- 25 20710, is continued to September 19th.

1 And that concludes our updated -- our

- 2 lastly updated information for continuances and
- 3 dismissals.
- In reference to that, we were --
- 5 MS. RYAN: I do have one correction.
- 6 EXAMINER LOWE: Yes, ma'am.
- 7 MS. RYAN: Case number 39, 20694 --
- 8 EXAMINER LOWE: What page is that on?
- 9 MS. RYAN: That is on page 10. Number 39
- 10 is a case that's consolidated with the other Mastiff
- 11 well cases that have been continued to August 30 -- or
- 12 excuse me -- October 31st.
- 13 EXAMINER LOWE: Which case number is that
- 14 now?
- 15 MS. RYAN: 20694. And it's the same as
- 16 20700, 20704 and 20706.
- 17 MS. SALVIDREZ: So did you submit a
- 18 continuance through the fees portal? Did you get an
- 19 approval?
- MS. RYAN: Mr. DeBrine --
- MR. DeBRINE: Yes, we did, on behalf of
- 22 EOG.
- MS. RYAN: All those cases are together.
- 24 MS. SALVIDREZ: And for what date?
- 25 MS. RYAN: We asked for a special docket in

- 1 October that we'll be communicating with dates with.
- 2 MR. DeBRINE: But the notice came through
- 3 that it was set for October 31st.
- 4 EXAMINER LOWE: Did you get all that,
- 5 Marty?
- 6 MS. SALVIDREZ: Yeah. I'll have to check
- 7 it.
- 8 EXAMINER McMILLAN: We have to be very
- 9 clear on this because we were given very explicit
- 10 instructions on how this is supposed to proceed.
- 11 EXAMINER LOWE: Yeah. We were given a
- 12 notice as of July 26th. I'm not sure if you-all have
- 13 been made aware of this. It's been put on our website.
- 14 Basically, it states as follows:
- 15 "Continuances for cases set for hearing
- 16 before the OCD:
- 17 "This notice is to provide guidance for OCD
- 18 staff on how motions for continuances are to be handled
- 19 under NMSA 1978, Section 70-2-39, OCD fee law and OCD
- 20 Rule 19.15.4.13C NMAC. The OCD fee law requires that a
- 21 motion for continuance be accompanied by a fee of \$150.
- 22 The motion and the fee must be filed via the OCD fees
- 23 portal before the OCD can process the motion for
- 24 continuance.
- 25 "OCD Rule 19.15.4.13C requires that,"

- 1 quote, "'parties shall file and serve motions for
- 2 continuances no later than 48 hours prior to the time
- 3 the hearing is set to begin, unless the reasons for
- 4 requesting a continuance arise after the deadline, in
- 5 which case the party shall file the motion as
- 6 expeditiously as possible after becoming aware of the
- 7 need for continuance, ' " end quote.
- 8 "Beginning July 26th, 2019, any motion for
- 9 continuance made (A) without payment of fees; (B)
- 10 without the showing required by 19.15.4.13C for motions
- 11 filed less than 48 hours prior to the hearing; or (C)
- 12 filed after 4:00 p.m. the day before the hearing,
- including verbal motions made on the day of hearing,
- 14 will be denied and the case dismissed without prejudice.
- 15 The case may then be refiled as a new case with the
- 16 associated fee.
- 17 "If no motion for continuance has been
- 18 granted and the applicant appears at the hearing and
- 19 claims to be unprepared or unable to move forward with
- 20 their case set for the docket, the case shall be
- 21 dismissed without prejudice and may be refiled as a new
- 22 case with the associated fee.
- "If an opposed motion for continuance is
- 24 timely filed and fees paid, a hearing on the motion will
- 25 occur. If the hearing examiner denies the motion, the

1 case will be heard regardless of whether the moving

- 2 party is prepared or not."
- 3 That's what -- is our policy we are
- 4 required to go through as of July 26th. So I'm not too
- 5 sure if you-all were made aware of this or not, but
- 6 everything -- all the continuances and dismissals have
- 7 to be in form with the OCD and go through Marlene. She
- 8 will verify all the docket. And she and I get together
- 9 prior to any hearing -- or any hearing examiner to find
- 10 out what cases are dismissed and/or continued.
- 11 MS. SALVIDREZ: I'll double-check that, but
- 12 I'm pretty sure I only have three. So I'll double-check
- when I get to my office on that one.
- 14 EXAMINER LOWE: And, once again, what were
- 15 those cases you mentioned, just the case numbers?
- 16 MS. RYAN: 20694, 20700, 20704, 20706.
- 17 EXAMINER LOWE: 20694, 20700, 20704 and
- 18 20706.
- 19 MS. RYAN: Yes. Those were all filed by
- 20 EOG. EOG entered an appearance and requested a
- 21 continuance. We agreed to it. They filed the
- 22 continuances, so if there is a fee or something to be
- 23 paid on their end, I know they'll take care of it.
- MR. DeBRINE: Yeah. We timely filed the
- 25 agreed motions for continuances in accordance with the

1 rule. And I don't know if we left one of them out and

- 2 didn't file it for this case and that's what happened,
- 3 but the intent was to file continuances with respect to
- 4 each of the COG Mastiff cases. And so if we could
- 5 just -- we'll follow up and file a formal motion because
- 6 they're all related cases that should have been
- 7 continued. And if we made an error, we apologize.
- 8 We'll fix that.
- 9 EXAMINER DAVID: Just for the record, did
- 10 you pay the fee?
- MR. DeBRINE: We paid the fee for all three
- 12 and then we filed. But if we left one off and we
- inadvertently didn't file for that one, we'll follow up
- 14 and with file a formal motion and pay the fee,
- 15 obviously.
- 16 EXAMINER McMILLAN: And the case has to be
- 17 dismissed.
- 18 EXAMINER LOWE: More than likely, that case
- 19 will have to be dismissed.
- 20 MS. RYAN: Mr. Examiner, that's not fair.
- 21 This is Concho's case that we --
- 22 EXAMINER McMILLAN: We understand it's
- 23 Concho's case, but we have a directive that we have to
- 24 follow. If you have a problem with it, you need to talk
- 25 to the director. We are told we are to follow this. So

1 the best advice I can give you is to talk to the

- 2 director.
- 3 MS. RYAN: I'm just going to state on the
- 4 record here --
- 5 EXAMINER McMILLAN: That's fine.
- 6 MS. RYAN: -- I have the right. Concho
- 7 filed this case. If there is an error that occurred by
- 8 another party that's entered an appearance in this case,
- 9 that should not affect our filing of the case, and it
- 10 can easily be corrected with filing of the fee. So yes,
- 11 I will take it up with the director.
- 12 EXAMINER McMILLAN: Thank you very much.
- 13 EXAMINER LOWE: Thank you.
- MR. DeBRINE: And I would just add that the
- 15 rule does allow for -- for allowances for special
- 16 circumstances, and I think this is one of them, and it
- 17 could easily be fixed by the filing a formal motion
- 18 later today with the fee --
- 19 EXAMINER McMILLAN: Yeah. That's fine.
- 20 MR. DeBRINE: -- instead of a dismissal.
- 21 EXAMINER McMILLAN: We're told we're
- 22 supposed to follow this verbatim. That's all we can do.
- 23 MS. SALVIDREZ: And we did talk about
- 24 special circumstances yesterday with management, and
- 25 that's like very rare, and it's, you know, you missed

- 1 your flight, a witness missed a flight, death in the
- 2 family. So it's kind of rare. So we'll have to talk to
- 3 management on this.
- 4 MR. DeBRINE: Okay.
- 5 EXAMINER LOWE: Or as Michael mentioned,
- 6 you-all can bring it up with the director and bring that
- 7 to light, because we were told to do this, and we're
- 8 just doing as we are told.
- 9 So on that note, being that -- from my
- 10 minimal experience on this, we've gone back to the old
- 11 format of the docket. And previously Will would put the
- 12 Excel spreadsheet together and we would kind of
- 13 correlate to how we're going to maneuver. But the way
- 14 it's panned out right now, I'm just going to go through
- 15 the cases in numerical order, unless there are cases out
- 16 there and instances you-all want to combine cases or put
- 17 them together.
- 18 Mr. Jim Bruce already mentioned that he
- 19 wants to do his cases toward the end of the day. So
- 20 right now we'll initially start out with the saltwater
- 21 disposal cases.
- 22 (The proceedings conclude, 8:32 a.m.)
- 23 (9:49 a.m.)
- 24 EXAMINER LOWE: Back on the record.
- I just want to put on the record that it

1 was clarified and justified that the cases that were

- 2 mentioned before to be continued for COG -- is that
- 3 correct -- Case Numbers 2694 [sic] --
- 4 MS. RYAN: Yes.
- 5 EXAMINER LOWE: -- and 2700 [sic], 2704
- 6 [sic] and 2706 [sic] are continued.
- 7 EXAMINER McMILLAN: Does counsel for EOG
- 8 have any objections?
- 9 MR. DeBRINE: No.
- MS. RYAN: Thank you.
- 11 (The proceedings conclude, 9:49 a.m.)
- 12 (4:00 p.m.)
- 13 MR. BRUCE: Case Numbers 20669 and 20300,
- 14 the Sundown well and Pavo Frio well, and Case Number 22,
- 15 20675, is the Sandlot well. In looking at the data,
- 16 there are notice issues. So if I have to dismiss and
- 17 refile, just let me know. Otherwise, I'll continue them
- 18 for --
- 19 EXAMINER LOWE: Which one would that one
- 20 be?
- 21 MR. BRUCE: All three of them had notice
- 22 issues.
- 23 EXAMINER McMILLAN: We're going to dismiss
- 24 them.
- 25 EXAMINER LOWE: So basically you're saying

Page 13 20669, Case Numbers 20300 and 20675 have notice issues? MR. BRUCE: Yes. 2 3 EXAMINER LOWE: According to our new procedures, those cases will have to be dismissed and 4 5 have to be refiled. 6 MR. BRUCE: Okay. I'll take care of that. 7 EXAMINER McMILLAN: So it's 669, 330. And 8 what was the other one? 9 EXAMINER LOWE: 675. MR. BRUCE: 20675. 10 11 EXAMINER LOWE: Due to renotice. 12 MR. BRUCE: I know. I understand. Such is 13 life. 14 EXAMINER McMILLAN: Okay. (The proceedings conclude, 4:01 p.m.) 15 16 17 18 19 20 21 22 23 24 25
