NGL seeks an order approving disposal into the Silurian-Devonian formation through the Thunderbolt SWD #1 well at a surface location 910 feet from the North line and 250 feet from the East line of Section 19, Township 26 South, Range 35 East, NMPM, Lea County, New Mexico for the purpose of operating a salt water disposal well. NGL seeks authority to inject salt water into the Silurian-Devonian formation at a depth of 18,966' to 20,722'. NGL further seeks approval of the use of 7 inch tubing inside the surface and intermediate casings and 5 ½ inch tubing inside the liner and requests that the Division approve a maximum daily injection rate for the well of 50,000 bbls per day.
