In **Case No. 20815**, Novo seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the W/2 W/2 of Sections 10 and 15, Township 23 South, Range 29 East, NMPM, Eddy County, New Mexico dedicated to the following proposed wells:

- The **Saturninus Fed Corn 1510 #11111 Well**, the **Saturninus Fed Com 1510 #121H Well**; and the **Saturninus Fed Corn 1510 #13111 Well**, each of which will be horizontally drilled from a common surface location in the SW/4 SW/4 (Unit M) of Section 15 to bottom hole locations in the NW/4 NW/4 (Unit D) of Section 10.

In **Case No. 20816**, Novo seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the E/2 W/2 of Sections 10 and 15, Township 23 South, Range 29 East, NMPM, Eddy County, New Mexico dedicated to the following proposed wells:

- The **Saturninus Fed Corn 1510 #112H Well**, the **Saturninus Fed Corn 1510 #122H Well**, and the **Saturninus Fed Corn 1510 #132H Well**, each of which will be horizontally drilled from a common surface location in the SW/4 SW/4 (Unit M) of Section 15 to bottom hole locations in the NE/4 NW/4 (Unit C) of Section 10.

Chevron is an interested party provided with notice of the applications.

No witnesses or exhibits are anticipated to be presented.


